#### ✦ **Multinational Corporation in the defence sector**

- Represented a multinational corporation in the defence sector in Abu Dhabi on a commercial dispute arising from contractual obligations with an amount in dispute of USD24 million.

## 🔗 **Prominent Real Estate Developer**
