He was initially assigned to Bakersfield, California where he advised the exploration and production business. In 1994, he was transferred to London, UK, where he advised the Shipping and Trading group and became the Shell group senior shipping lawyer. After five years in Calgary, he moved to Houston, TX where he became General Counsel – Upstream Americas and GC for Shell Oil Company. Most recently he was named General Counsel – Projects and Technology in The Hague, Netherlands.


