Vyanmar Your Foray into the Golden Land

With changes to Myanmar's Foreign Investment Law and the increase in the government's expenditure on healthcare, the Golden Land is fast attracting many pharmaceutical and healthcare companies to its shores. Since 2012, Myanmar has seen rapid increase in the demand for healthcare products. The total pharmaceutical expenditure has increased from USD 390 million in 2014 to USD 440 million in 2015. Myanmar's Ministry of Health also plans to increase healthcare budget allocation with an annual growth rate of 6% until 2020.

As with many other countries, it is no surprise that the pharmaceutical industry is subject to regulatory scrutiny by the MOH and relevant agencies, which issue licenses permitting the import, manufacture and marketing of drugs and food, amongst others.

The Department of Health, one of the 7 departments under the MOH, is primarily responsible for the provision of healthcare throughout the country. Healthcare infrastructure is further supplemented by private healthcare providers, and the industry is regulated by several laws, including the Law Relating to Private Health Care Services and the Public Health Law of 1972.

The Food and Drugs Administration and the Myanmar Food and Drug Board of Authority administer the National Drug Law of 1992, the National Food Law of 1997 and the Traditional Drug Law of 1996. Directives issued under those laws also address product safety, labelling and advertisement requirements for drugs and food products which are marketed in Myanmar.

Like the rest of the region, Myanmar has until 2015 to implement these into law. In the interim, cosmetics are governed by the Public Health Law of 1972 and appear to fall within the purview of the FDA.
