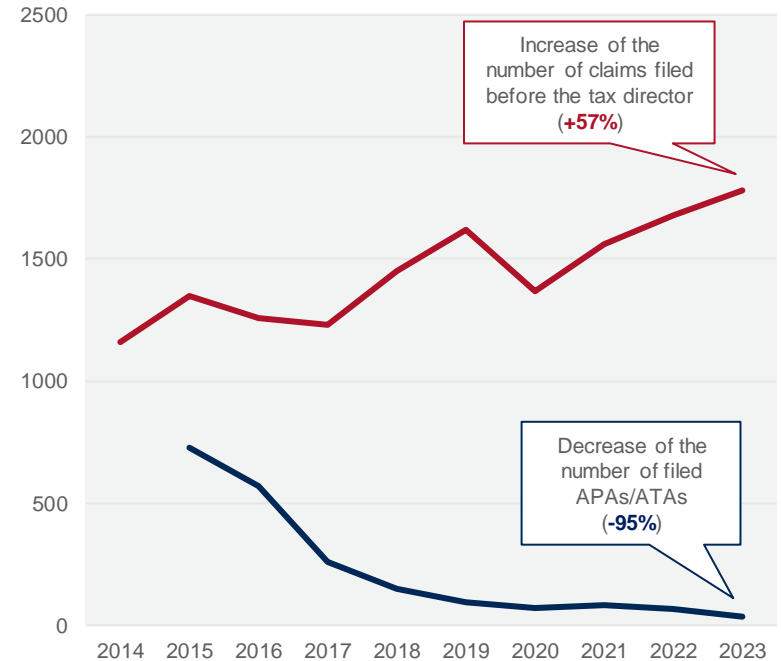
TAX FROM EVERY ANGLE

Where we are now

As in other countries, the Luxembourg tax landscape has shifted in recent years, driving greater uncertainty and increased risk when it comes to (inter)national tax and transfer pricing controversy.

We continue to see year-on-year increases in the number, value and sophistication of tax disputes and audits.

Faced with this situation, the courts are taking actions, starting in September 2023 with the creation of a new chamber at the administrative tribunal, making a move towards specialization, encouraged by a multi-year recruitment program.



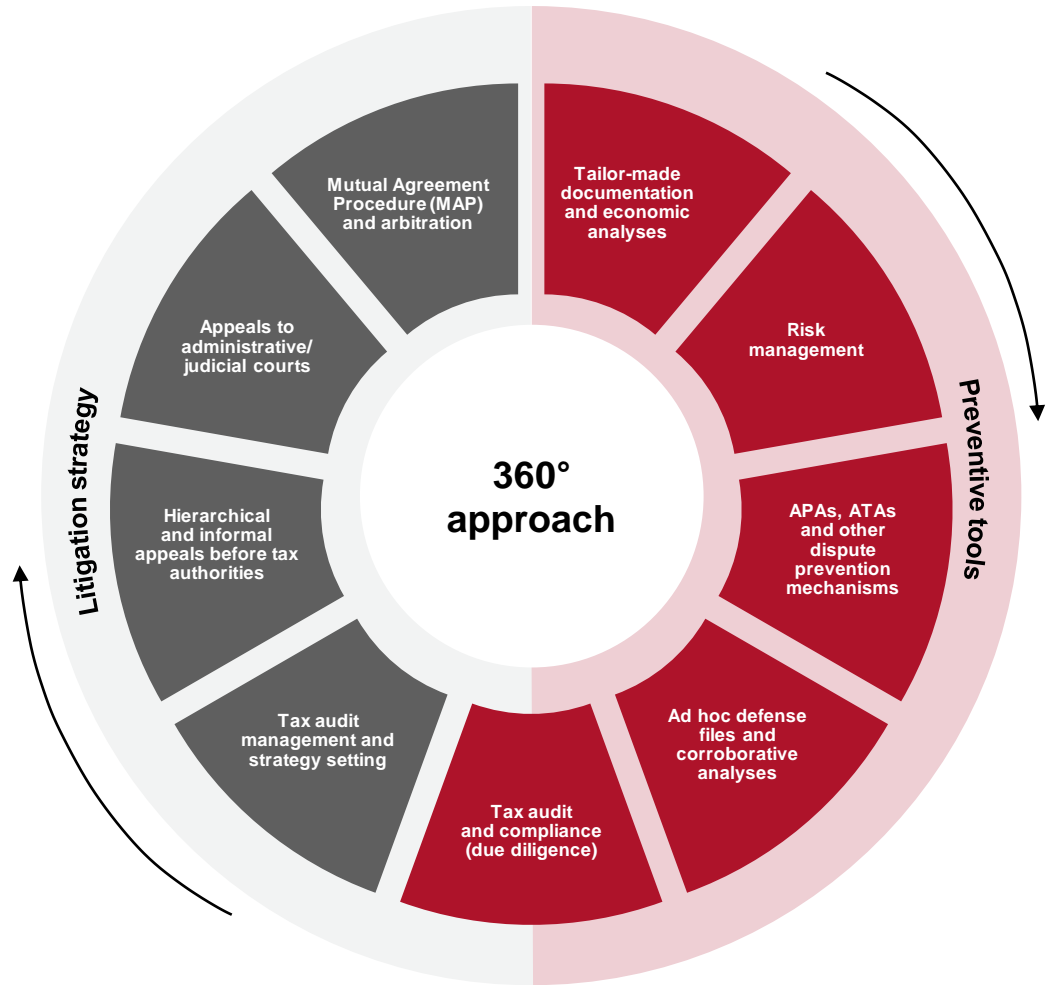
