- Advised ZCCM Investment Holdings plc in relation to the African merger control aspects of the proposed acquisition by Delta Mining Limited of 51% of Mopani Copper Mines (MCM) from ZCCM. MCM is a Zambian copper producer and exporter, operating two mine sites at Mufulira and Nkana, located on the Copperbelt Province.
- Advised Hong Kong-based Hutchison Ports Group in the COMESA merger notification of its
 proposed transaction with COSCO Shipping and CMA CGM for the establishment of a joint
 venture that will construct, develop, use, manage, operate, exploit, and maintain a container
