Corporate Compliance

- Assisted a major multinational pharmaceutical company to conduct a large scale FCPA investigation in respect of its business activities in China. This includes interviewing key employees, conducting e-discovery, review evidence and providing recommendations.
- Conducted an internal investigation and interview of several employees of a local subsidiary of a NYSE listed company on anti-bribery/corruption involving its PRC employees including advising on disciplinary actions against the relevant employees.
- Conducted an investigation on bribery allegations against quality control inspectors of a major North American company. The management of the company became aware of the allegations due to information provided by a whistle-blower. The investigation and interview cover external suppliers of several well- known retailers in North America and client's employees. Our work included advice on the grounds for taking disciplinary actions against the relevant employees.
- Conducted an internal investigation for a North American retailer in relation to bribery allegations provided by a supplier against a sourcing manager of the company; conducted document review and interview of the relevant employee; recommended with follow-up actions.

Commercial Litigation

Our client was involved in a dispute with its China distributor concerning outstanding payments due for products supplied by client to the distributor. We helped with the negotiation and drafting of a complex settlement agreement which involved settlement and assignment of debts by various group companies between the parties located in China and Hong Kong.

This includes formulating defense strategies and supervising local counsel in the conduct of the case. The case was finally dismissed by the Chinese court on a number of technical and substantive grounds.

The instruments were sold to a local end user under our client's brand. The products had many defects and as a result, our client was claimed by their end users. We helped client negotiate a settlement to settle the claims.

 agreement. The decision has a major impact on the local supplier and its
 ability to continue as a going concern. Local government authority was also

International Arbitration
