

Representative Legal Matters

- Representing a major Asian company in domestic arbitration proceedings filed by a major Colombian company pursuant to the civil works contract entered into between the parties for the constructions of a power plant. The award was recently issued upholding the arguments we raised in defense of our Asian client.
- Representing the subsidiary of a major British company in a dispute that provided for international arbitration seated in New York regarding breach of a multimillionaire stock purchase agreement of a Colombian company, under ICC rules.
- Representing eight infrastructure companies (located in Colombia Panama BVI and UK) who
 were respondents in international arbitration proceedings, under ICC rules, seated in Houston,
 regarding a dispute related to the design, engineering and procurement of turbines and
 associated equipment for a power plant project in Panama.
- Representing a major French company in international arbitration proceedings, under ICC rules, seated in New York, regarding the disputes that arose for alleged breach of representations and warrantied within an interest purchase agreement of a Colombian company.
- Representing a major Asian consortium in international arbitration proceedings against a state owned company regarding the breach of an EPC contract for the engineering, acquisition, construction, installation and commercial operation of a power plant in Colombia.
- Representing Finosca S.A.S. (owned by Total) within a class action in which claimants are seeking the recognition and payment of damages allegedly caused by an oil spill that occurred on 20 July 2014 in the port located near Tolú, Coveñas and San Antero in the Republic of Colombia.
- Representing a major Asian company in international arbitration proceedings against a major Colombian company to claim for damages due to the breach of the obligations under a civil works contract for the construction of a power plant in Colombia.
- Representing Ferring International Center S.A. within a litigation brought by a local company seeking the declaration of a de facto commercial agency agreement. The plaintiff is claiming payment of the commercial severance pay and the equitable indemnity due under Colombian law to commercial agents upon termination of the relationship.
- Representing a major American engineering company in a very complex litigation regarding
 the damages allegedly caused to a steam turbine during the construction of a power plant in
 Colombia.



- Representing Embraer in a lawsuit filed before Colombian courts in which plaintiff claims payment of the amounts due at the termination of an alleged agreement for the promotion and sales of Embraer's aircrafts and spare parts and damages.
- Representing the subsidiary of a major British company in the litigation brought against an alleged commercial agent claiming payment of damages and payments due at termination of the relationship.
- Advising the subsidiary of a German pharmaceutical company in the issues and problems that arose after purchasing a local pharmaceutical company which put the investment at risk.
- Representing an American company specialized on inspecting submarine pipelines in the arbitration filed by a state owned oil company due to alleged breach of contract.
