## **Aircraft and Equipment Leasing and Finance**

- Acting for major airlines in China (including Air China, China Eastern Airlines and China Southern Airlines) in relation to aircraft transactions involving domestic and foreign banks, and domestic and foreign leasing companies, including sale and purchase transactions, operating leases, sale and leaseback transactions, finance leases, free-trade-zone structured lease, Japanese operating leases, French tax optimized leases, ECA/EXIM supported financing transactions and pre-delivery finance for over 600 aircraft for the past 19 years.
