Healthcare & life sciences

- Advised and represented a client in the health and pharmaceutical sector, successfully challenging and setting aside the General Regulations published under the Medicines and Related Substances Act to the extent that they apply to 'complementary medicines' and 'health supplements'. The matter was finally determined in the Supreme Court of Appeal (SCA). *
- Advised and represented a consortium of pharmaceutical companies where the court was required to determine whether the term "beneficial interest" in Regulation 6 of the Ownership and Licensing of Pharmacies, under the Pharmacy Act, includes shareholding in a company that owns a pharmacy business. The case was ultimately resolved in the Constitutional Court. *
- Advised a global biopharmaceutical company on the importation and distribution of biopharmaceutical and biosimilar products manufactured in India and Malaysia for sale and distribution to hospitals and pharmacies in South Africa. The advice specifically outlined the regulatory framework under the Medicines and Related Substances Act, its Regulations, and the relevant SAHPRA guidelines. *
