

## Representative Legal Matters

- Act for Korea Water Resources Corporation, a major Korean company engaged in comprehensive water resource development and providing both public and industrial water in South Korea, on matters relating to the project company's Concession Agreement with the Metropolitan Waterworks and Sewerage System for the Bulacan Bulk Water Supply project under the Philippine PPP program, drafting and negotiation of technical service agreements, joint venture agreement with a Philippine conglomerate, and accession agreement to an omnibus loan and security agreement with a consortium of Philippine banks.
