



Representative Legal Matters

- Represent a leading mineral processing company in the Philippines in proceedings for enforcement of fixed-rate energy supply contract with claims for damages against a large power generator.
- Represent a foreign government agency in a case of injunction for its provision technical assistance in relation to a significant public infrastructure project.
