



# Representative Legal Matters

## **Airlines and Aircraft Operators**

- Represents US and foreign airlines in aviation matters, including licensing, route proceedings, antitrust applications, code-share/joint venture agreements, restructuring, commercial, and transactional matters.
- Represents major airlines in multi-billion dollar financings involving regulatory collateral.
- Represented multiple start-up U.S. airlines, including Virgin America, and Avelo Airlines in commercial, governance, and regulatory matters associated with obtaining operational approvals.
- Represented Aer Lingus in connection with its application for antitrust immunity as part of the American Airlines and British Airways joint venture.

## **Private Equity/Investors**
