World Trade Organization (WTO)

WTO members fix dates for Astana Ministerial Conference

WTO members have <u>agreed</u> that the organization's next Ministerial Conference will take place from 8 to 11 June 2020 in Astana, Kazakhstan. The dates were endorsed at an 18 October meeting of the WTO's General Council.

The General Council <u>agreed on 26 July</u> to accept Kazakhstan's offer to host the 12th Ministerial Conference in the Kazakh capital. Director-General Roberto Azevêdo met with President Nazarbayev of Kazakhstan in Astana on 27 September, where they reviewed preparations for the Ministerial Conference.

The Ministerial Conference is the WTO's top decision-making body and the <u>Marrakesh Agreement</u> establishing the organization instructs members to hold one at least every two years. The event is attended by trade ministers and other senior officials from the organization's 164 members.

The previous Ministerial Conference (MC11) was held in <u>Buenos Aires</u> in December 2017.

Australia accepted into Government Procurement Agreement

The WTO <u>announced</u> that on 17 October 2018, parties to the WTO plurilateral Government Procurement Agreement (GPA) unanimously approved a decision to welcome Australia as the 48th WTO member to be covered by the Agreement. Australia will officially become a GPA party 30 days after submitting its Instrument of Accession to the WTO's Director-General.

Australia will accede to the Agreement based on the terms set out in its final market access offer, which all GPA parties approved. This outlines to what extent Australia commits to opening its government procurement market to the current GPA parties. Preliminary calculations suggest that Australia's overall government procurement markets are worth AUD 110 billion (USD 78 billion), meaning that Australia's accession will add significantly to the current USD 1.7 trillion worth of government procurement covered by the Agreement.

Australia will submit its Instrument of Accession within a period of one year following the Committee's decision, after having ratified the decision domestically. Australia initiated negotiations to join the Agreement three years ago, in September 2015.

The GPA aims to open up, in a reciprocal manner and to the extent agreed between WTO members, government procurement markets to foreign competition, and make government procurement more transparent. It provides legal guarantees of non-discrimination for the products, services or suppliers of GPA parties in procurement covered by the Agreement. The GPA is a plurilateral agreement — potentially open to all WTO members and binding only the parties to the Agreement. Currently, <u>47 WTO members</u> (including the EU and its 28 member states) are bound by the Agreement.

Progress on the United Kingdom's GPA accession

The WTO <u>announced</u> that at the 17 October 2018, meeting, GPA parties reviewed the UK's revised market access offer as part of its bid to join the GPA in its own right after its departure from the European Union. All GPA parties that spoke expressed a clear desire that the UK continue to participate in the Agreement in a seamless manner post-Brexit, on terms that are mutually acceptable.

The UK made clear that it intends to update its proposed GPA schedules of commitments within three months of their coming into effect, using the <u>procedures set out in the Agreement</u>. Many parties said they can already approve, in principle, the UK's accession (in some cases subject to related conditions). Others called on the UK to pro-

vide further clarity on its eventual coverage and/or to address other concerns before the accession can be concluded. The UK's accession will be further considered at the Committee's end-of-year formal meeting, scheduled for 27 November.

Under negotiation is a government procurement market worth at least GBP 67 billion (USD 88 billion), the UK said at the Committee's <u>meeting</u> in June (based on 2013 figures).

The UK launched its GPA negotiations in June by submitting to parties an initial market access offer and replies to a checklist on its national government procurement legislation. As an EU member, the UK has been participating in the GPA for over 20 years.

Trade Policy Review: Vanuatu

The first review of the trade policies and practices of Vanuatu took place on 23 and 25 October 2018. The basis for the review was a <u>report by the WTO Secretariat</u> and a report by the Government of Vanuatu.

TBT Notifications

Member countries of the WTO are required under the *Agreement on Technical Barriers to Trade* (TBT Agreement) to report to the WTO all proposed technical regulations that could affect trade with other Member countries. The WTO Secretariat distributes this information in the form of "notifications" to all Member countries. World Customs Organization (WCO)

62nd Session of the WCO Harmonized System Committee (HSC)

The WCO <u>announced</u> that the Harmonized System Committee (HSC) held its 62nd Session from 17 to 28 September 2018 at WCO Headquarters in Brussels. The session was attended by more than 170 participants representing 85 Contracting Parties to the HS Convention, one WCO Member administration and four international and regional organizations.

During his opening address Mr. Ping LIU, Director for the Tariff and Trade Affairs Directorate, welcomed the new Arabic and Portuguese speaking delegates and interpreters. In addition to the four languages normally used at the HSC (English and French as official languages, Spanish and Russian as working languages), HSC/62 would also be interpreted into Arabic and Portuguese: the first WCO meeting of a two-year pilot project on the use of additional languages at WCO working bodies.

The Director also informed the Committee about the imminent launch of a new project, "Harmonizing the classification of goods based on WCO standards to enhance African trade". This project, initiated and funded by the EU and implemented by the WCO, aimed to contribute to the establishment of the African Continental Free Trade Area (AfCFTA), which was launched in March 2018, and assist beneficiary African countries to not only implement and apply the HS 2022 edition, but build the capacity to successfully apply future editions, autonomously and on time, in line with the requirements of HS Convention and the needs of international and regional agreements.

Concerning the WCO Council Recommendation regarding the amendment to Article 8 of the HS Convention, to restrict the number of reservations that can be entered in respect of HSC decisions to two, Mr. Ping LIU indicated if no objections are received by

the expiry of the reservation period (12 January 2019), the amendments shall enter into force on 1 January 2021.

The 62nd Session of the HSC was an exceptionally productive meeting. The Committee took 43 classification decisions related to products covered by the HS Nomenclature, including a novel tobacco product, several petroleum products and a quadrocopter, adopted three sets of amendments to the current Explanatory Notes and approved 21 new Classification Opinions.

As part of the work to prepare the Seventh Edition of the HS (HS 2022), the HSC provisionally adopted 16 sets of amendments to the Nomenclature (encompassing a large number of amendments and new provisions) and two sets of amendments to the future Explanatory Notes. Products of importance to trade such as light-emitting diode (LED) products and solar energy products, as well as those important for regulation such as Montreal Protocol gasses, will benefit from improved representation in the HS.

Comprehensive and Progressive Agreement for the Trans-Pacific Partnership (CPTPP)

CPTPP ratified by New Zealand, Canada and Australia – to enter into force on 30 December 2018

On 25 October 2018, New Zealand formally ratified the Comprehensive and Progressive Agreement for the Trans-Pacific Partnership (CPTPP) bringing the number of ratifications to four. Canada cleared its last legislative hurdle when the Senate approved it on October 25 and Royal Assent was given the same day. Canada became the fifth to ratify when it notified New Zealand of its ratification on October 29, 2018. The Australian House and Senate also approved it and sent it to the Governor General who has given Royal Assent. Australia brought the number of ratifications to six by notifying New Zealand of its ratification on October 31, 2018. The CPTPP will enter into force 60 days after six countries ratify the deal. Ratification occurs after a notice of ratification has been filed with the CPTPP Depositary country - New Zealand, so the CPTPP will enter into force on 30 December 2018 for those signatories who have ratified it. Japan, Mexico and Singapore were the first to ratify the CPTPP. Brunei, Chile, Malaysia, Peru and Vietnam are the remaining signatories. Vietnam is expected to ratify it in November. The CPTPP incorporates most of the Trans-Pacific Partnership (TPP) provisions by reference, but suspended 22 provisions the United States favored that other countries opposed, and lowered the threshold for enactment so the participation of the U.S. is not required. The TPP was signed on 4 February 2016, but never entered into force as a result of the withdrawal of the United States. The US had pushed for the original TPP under President Obama's administration, but President Trump withdrew from the agreement in January 2017, shortly after being sworn-in.

CPTPP Product Specific Rules of Origin: Identifying Opportunities for your Business

The Comprehensive and Progressive Agreement for the Trans-Pacific Partner-ship (CPTPP) is moving forward and has gained momentum recently as Japan, Singapore New Zealand and Mexico have formally ratified the 11-party agreement and Canada's and Australia's legislation has passed both house of Parliament and already received Royal Assent. As indicated above. It will enter into force on 30 December for those who have ratified it.

Even after the US withdrawal from the deal in January 2018, the agreement will enter into force by the end of 2018. And although there are already a number of FTAs in place among certain members of the CPTPP, this Mega-FTA, unprecedented in scale, is expected to have influence not only among the members, but also will impact globalization and potentially leave non-members behind.

In order to gain benefits for the preferential duty treatment, goods must meet the rules of origin (ROO). To be considered an originating product, it must be (i) produced exclusively of originating materials, (ii) either wholly obtained or produced in one or more of the CPTPP parties, or (iii) if it contains any non-originating imported materials, then it must meet additional requirements. For non-originating material there are also more complex rules of origin and these also include product-specific rules.

Rules of Origin and CPTPP Unique Features

Under the CPTPP a non-originating good receives preferential duty treatment if each of the non-originating materials used in the production of the good satisfies:

- any applicable change in the tariff classification requirements
- the production process requirements
- regional value content requirements
- or any other requirements specified in Annex 3-D (Product Specific Rules of Origin)

Some of the product-specific rules are complex, but when utilized will provide great benefit to claimants and attract the consolidation of supply chains to the participating countries.

Full accumulation

According to the World Customs Organization the CPTPP provides for "full accumulation". Under Art. 3.10 of the CPTPP, an originating good or material of one or more of the Parties that is used in the production of another good in the territory of another Party is considered as originating in the territory of the other Party. Full accumulation allows for greater fragmentation of the manufacturing process, which may be carried out among different member territories. This benefit will lighten tariff burdens on the movement of materials among the CPTPP members, consolidate supply chains among the members, increase the procurement of materials and parts from CPTPP members, and increase materials/parts investment in CPTPP member countries. There are different levels

of <u>accumulation</u> provided for in various FTAs and the CPTPP model is considered to be more trade facilitative compared to existing ASEAN agreements.

Self-certification system

ROO may be considered to be constraining factors for companies in terms of both procurement and production. This is true especially when ROO differ among FTAs and create differing Certification of Origin (COO) procedures. Presently, most FTAs in the region require government authorities to issue FTA certificates of origin and this increases administrative costs for claiming preferential duty. As a consequence, multiple FTAs create the "spaghetti bowl phenomenon", which in turn complicates trade and makes it more expensive.

However, under the self-certification system in the CPTPP, claimants can make a claim for preferential treatment based on a COO completed by the exporter, producer or importer and there is no need for the COO to be approved or authenticated by a government authority. The self-certification procedure will streamline trade and help untangle the spaghetti bowl. Note however, the self-certification under the CPTPP does require sufficient records to be kept for five (5) years and is subject to verifications which we discuss in our previous blog post available here.

How can you prepare?

Businesses should start to evaluate supply chains under the lense of the CPTPP rules of origin and the product-specific rules. Especially as the tariffs in the United States and China increase, duty savings under the CPTPP will be even more important. We have identified a few proactive steps you can take in order to prepare:

- Identify manufacturing opportunities in 11 members to the CPTPP. Are there suppliers and manufacturers in these countries?
- Consider whether your goods will qualify for tariff shift, RVC or other product specific rules. If so, begin to implement a COO compliance procedure and program.
- Ensure your contracts with your suppliers, manufacturers and freight forwarders include COO requirements.
- 4. Ensure sufficient records are kept for any CPTPP verification.

CANADA

CPTPP ratified by Canada – to enter into force on 30 December 2018

On 29 October 2018, Canada became the fifth signatory to ratify the *Comprehensive and Progressive Agreement for the Trans-Pacific Partnership* (CPTPP) when it <u>notified New Zealand of its ratification</u> bringing the number of ratifications to five. New Zealand had previously ratified the CPTPP and Australia followed Canada, providing the six ratifications to bring it into force on 30 December.

Canadian Government provides relief for Canadian business from countermeasures on certain US imports

In response to the imposition of the United States' tariffs on Canadian steel and aluminum, the Government of Canada applied reciprocal countermeasures on imports of steel, aluminum, and other products from the US, beginning on July 1, 2018. The Government recognizes that the Canadian countermeasures can create challenges for Canadian manufacturers that rely on steel and aluminum imported from the US. This imported steel and aluminum is used in many of Canada's major industries, including energy, advanced manufacturing, construction, and automotive parts. On October 11, 2018, the Government outlined a framework that allows the Government to consider providing targeted relief from Canada's countermeasures in the following instances:

- Situations of short supply in the domestic market, either on a national or regional basis;
- Situations where there are contractual requirements, existing prior to May 31, 2018, for Canadian businesses to use U.S. steel or aluminum in their products or projects; and
- Other exceptional circumstances that could have severe adverse impacts on the Canadian economy.

A federal interdepartmental committee reviewed the requests received from Canadian companies for targeted relief from Canada's countermeasures and made recommendations to the Minister of Finance. Under section 115 of the Customs Tariff, the Minister of Finance has the authority to recommend to the Governor in Council that relief be provided in the form of remission of the countermeasures.

The *United States Surtax Remission Order* provides targeted relief from countermeasures for a number of steel and aluminum products determined to be in short supply in Canada. The federal interdepartmental committee consulted domestic steel and aluminum producers to assess supply conditions.

For certain products determined to be in situations of ongoing short supply and listed in Schedule 1 of the Remission Order, relief can be granted from surtaxes paid or payable under the <u>United States Surtax Order (Steel and Aluminum)</u> for an indefinite period (for products imported from the U.S. on or after July 1, 2018).

For certain products determined to be in situations of temporary short supply and listed in Schedule 2 of the Remission Order, relief can be granted from surtaxes paid or payable under the *United States Surtax Order (Steel and Aluminum)* for a time-limited period (for products imported from the U.S. from July 1, 2018 to December 31, 2018).

On October 11, 2018, the Canada Border Services Agency (CBSA) issued <u>Customs Notice 18-16 United States Surtax Remission Order</u>, which provides information on the introduction and application of the *United States Surtax Remission Order*, 2018-1272, which is intended to minimize the negative effects of the surtaxes on Canadian companies and the economy by providing relief in exceptional situations.

The remission order remits the surtaxes imposed by the *United States Surtax Order (Steel and Aluminum)*: <u>SOR/2018-152</u> and the *United States Surtax Order (Other Goods)*: <u>SOR/2018-153</u> which took effect on July 1, 2018 (25% in the case of certain steel products, 10% in the case of certain aluminum products and 10% for certain other goods listed in the order) under the following situations:

- Pursuant to section 115 of the <u>Customs Tariff</u>, in respect of the goods listed in Schedule 1 and Schedule 2 of the remission order;
- Pursuant to section 115 of the <u>Customs Tariff</u>, in respect of goods classified under tariff item No. 8903.10.00, 8903.91.00, 8903.92.00 or 8903.99.90 in the List of Tariff Provisions set out in the schedule to the <u>Customs Tariff</u>, excluding those that have been exported from Canada and then subsequently re-imported into Canada; and
- Goods temporarily imported into Canada for the purposes of repair, alteration, or storage, including those classified under tariff item No. 8903.10.00, 8903.91.00, 8903.92.00 or 8903.99.90 that have been exported from Canada.

CN 18-16 explains how to make remission claims, account for relief of the surtax, and how to make corrections, obtain re-determinations and obtain refunds.

Global Affairs, CBSA, CITT publish steel safeguards procedures; WTO notified

On October 11, 2018, Global Affairs Canada published Notice to Importers: Item 82 – Steel Goods (Serial No. 911) which informs importers of the procedures governing the administration of provisional safeguards, in the form of tariff rate quotas (TRQ), for certain steel goods that are listed in item 82 on the Import Control List (ICL). These goods were added to the ICL to implement the Order Imposing a Surtax on the Importation of Certain Steel Goods (Surtax Order). The Surtax Order establishes provisional safeguards in the form of TRQs for steel goods matching the product descriptions specified in the column 2 of the Schedule to the Surtax Order, above which a twenty-five percent surtax will apply.

The Notice applies to steel goods imported from all countries other than those originating in and imported from:

· the United States;

- Chile;
- Mexico, other than energy tubular products and wire rod originating in and imported from Mexico;
- Israel or another CIFTA beneficiary; and
- a country benefiting from the General Preferential Tariff, other than concrete reinforcing bar originating in and imported from Vietnam.

The Notice does not apply to imports of steel products that do not meet the <u>product definitions</u>. Goods that are not subject to the Surtax Order may continue to be imported under General Import Permit 80 or General Import Permit 81, as the case may be.

The TRQs will be administered by way of shipment-specific import permits. The application period for shipment-specific import permits will open on October 25, 2018. The TRQs will be administered until the Surtax Order is amended or repealed by the Governor in Council, or ceases to have effect pursuant to section 56 of the *Customs Tariff*.

The Notice will remain in effect until further notice.

CBSA implementation

On the same date as the Global Affairs posting, the Canada Border Services Agency (CBSA) issued <u>Customs Notice 18-17: Provisional Safeguard Measures Imposed on the Importation of Certain Steel Goods</u>. The notice provides information on the implementation of the Surtax Order, which comes into force October 25, 2018. In addition to the Global Affairs information, CBSA points out that:

- The 25% safeguard surtax is applied on the value for duty of goods determined in accordance with sections 47 to 55 of the Customs Act.
- Absent a specific permit, the safeguard surtax will apply to all goods including those released from a Customs Bonded Warehouse or Sufferance Warehouse on or after October 25, 2018 when the Order comes into force.
- Canada's <u>Duties Relief Program</u> and <u>Duty Drawback</u> Program continue to be available to importers for duties relief, including safeguard surtaxes, paid or owed by businesses that meet the requirements of these programs.
- The burden of proof that goods do not originate from an applicable country as
 defined in the Order lies with the importer.
- Proof of origin may be in the form of a commercial invoice, a Canada Customs Invoice, a Form A - Certificate of Origin, an Exporter's Statement of Origin, a Certificate of Origin pursuant to a Free Trade Agreement, or any other acceptable documentation that clearly indicates the country of origin of the goods.
- To confirm whether imported goods are subject to the safeguard surtax, the CBSA may require importers to provide the following documentation:
 - o Specific permit
 - o Purchase invoice or order
 - o Bill of lading
 - o Mill certificate
 - Product literature and technical specifications
 - Any other document to substantiate whether the goods are subject to the safeguard surtax

The CBSA Notice explains how to make corrections to original declarations, requests for re-determinations or further re-determinations, and applications for a refund as well as the process for Customs Self Assessment (CSA) clients. Decisions made by the CBSA may be subject to appeal under the <u>Customs Act</u>.

CITT investigation and procedures

The Canadian International Trade Tribunal (CITT) will be conducting the investigation. Deadlines and procedures related to the participation of interested parties in the inquiry are set out in the Notice of Commencement of Safeguard Inquiry published by the CITT and available on the CITT's website. Importers, exporters and other interested parties will be able to present evidence and their views during the inquiry, up to and during the hearing to be scheduled by the CITT.

WTO notification

The WTO <u>announced</u> that Canada notified the WTO's Committee on Safeguards that on 11 October 2018 it initiated a safeguard investigation on certain steel products. Further information is available in G/SG/N/6/CAN/4.

MEXICO

Agreement reached for the modernization of the trade relationship in North America

On September 30, 2018, the governments of Canada, Mexico and the United States reached an agreement regarding the amendments for the modernization of the *North American Free Trade Agreement* ("NAFTA").

Two days before, on September 28, 2018, the Minister of Economy himself filed another document with the Senate, explaining that the negotiation with Canada was still ongoing, and that the texts of the agreement were going to be released once an agreement with Canada was reached (if that happened).

On September 30, the <u>full text of the agreement</u> reached by the three parties was filed before the Mexican Senate.

The text of this new agreement, known as the *United States-Mexico-Canada Agreement* (USMCA), is available on the website of the Mexican Ministry of Economy. It is important to bear in mind that these texts are published for informative purposes only, that they may be further amended and are subject to legal review.

President issues Proclamation 9813 revising GSP status

On October 31, 2018, the *Federal Register* published Presidential <u>Proclamation</u> 9813 - To Modify the List of Products Eligible for Duty-Free Treatment Under The <u>Generalized System of Preferences</u>. The proclamation provides that:

- (1) In order to provide that several countries should no longer be treated as beneficiary developing countries with respect to one or more eligible articles for purposes of the GSP, the Rates of Duty 1-Special subcolumn for the corresponding HTS subheadings and general note 4(d) to the HTS are modified as set forth in sections A, B, C, and D of Annex I to the proclamation.
- (2) In order to redesignate a certain article as an eligible article for purposes of the GSP, the Rates of Duty 1-Special subcolumn for the corresponding HTS subheadings and general note 4(d) to the HTS are modified as set forth in sections E and F of Annex I to the proclamation.
- (3) A waiver of the application of section 503(c)(2) of the 1974 Act shall apply to the eligible articles in the HTS subheadings exported by the beneficiary developing countries as set forth in Annex II to the proclamation.

The modifications to the HTS set forth in Annexes I and II of Proclamation 9813 shall be effective with respect to articles entered for consumption, or withdrawn from warehouse for consumption, on or after 12:01 a.m. eastern daylight time on November 1, 2018

President continues national emergencies with respect to Colombian narcotics traffickers and the DR of the Congo

On October 18, 2018, the *Federal Register* published <u>Notice of October 17, 2018</u> - Continuation of the National Emergency With Respect to Significant Narcotics <u>Traffickers Centered in Colombia</u>, which extends for an additional year, the national emergency first declared on October 21, 1995 in Executive Order 12978. The national emergency is being extended because the actions of significant narcotics traffickers centered in Colombia continue to threaten the national security, foreign policy, and economy of the United States and cause an extreme level of violence, corruption, and harm in the United States and abroad.

On October 26, 2018, the *Federal Register* published <u>Notice of October 25, 2018</u> - Continuation of the National Emergency With Respect to the Democratic Republic of the Congo, which extends for an additional year, the national emergency first declared on October 27, 2006, in Executive Order 13413 and additional measures declared on July 8, 2014 in Executive Order 13671, to deal with the unusual and extraordinary threat to the foreign policy of the United States constituted by the situation in or in relation to the Democratic Republic of the Congo, which has been marked by widespread violence and atrocities and continues to threaten regional stability. The national emergency is being extended because the situation in or in relation to the Democratic Republic of the Congo continues to pose an unusual and extraordinary threat to the foreign policy of the United States.

Opioids bill signed by the President

On October 3, 2018, the US Senate passed <u>H.R. 6</u>, the *Substance Use-Disorder Prevention that Promotes Opioid Recovery and Treatment for Patients and Communities Act*, by a vote of <u>98-1</u> (after the House of Representatives passed the legislation last week by a vote of <u>393-8</u>). The Act incorporates approximately 70 individual bills and multifaceted programs to address the opioid problem. One of the provisions would require advance data on all international mail by 2020 to assist US Customs and Border Protection (CBP) and the US Postal Service interdict small fentanyl and carfentanil shipments, that are shipped through international mail channels, particularly from China. The 250 page bill was signed by President Trump on October 24, 2018 (Pub. L. 115-271).

Administration announces intent to negotiate trade agreements with Japan, EU and UK

On October 16, 2018, the Office of the US Trade Representative (USTR) announced that, at the direction of the President, USTR Robert Lighthizer notified Congress that the Trump Administration intends to negotiate three separate trade agreements with Japan, the European Union and the United Kingdom.

"Under President Trump's leadership, we will continue to expand U.S. trade and investment by negotiating trade agreements with Japan, the EU and the United Kingdom," said Ambassador Lighthizer. "Today's announcement is an important milestone in that process. We are committed to concluding these negotiations with timely and substantive results for American workers, farmers, ranchers, and businesses."

In officially notifying Congress, the U.S. Trade Representative (USTR) is following the procedures set out in the *Bipartisan Congressional Trade Priorities and Accountability Act of 2015* – often referred to as Trade Promotion Authority (TPA) – which requires ongoing consultations with Congress. These consultations ensure that USTR develops negotiating positions with the benefit of Congress' views. USTR will also publish notices in the *Federal Register* requesting the public's input on the direction, focus and content of the trade negotiations.

In accordance with TPA, USTR will publish objectives for the negotiations at least 30 days before formal trade negotiations begin.

The letters regarding Japan and EU indicate an intention to begin negotiations as soon as practicable, but no earlier than 90 days from the date of the letter. The letter regarding the UK indicates an intention to initiate negotiations with the UK as soon as it is ready after it exits from the EU on March 29, 2019.

- US goods and services trade with Japan totaled an estimated \$283.6 billion in 2017. Exports were \$114 billion; imports were \$169.5 billion. The US goods and services trade deficit with Japan was \$55.5 billion in 2017.
- US goods and services trade with the EU totaled nearly \$1.2 trillion in 2017. Exports totaled \$527 billion; Imports totaled \$627 billion. The US goods and services trade deficit with the EU was \$100 billion in 2017.
- US goods and services trade with United Kingdom totaled an estimated \$235.9 billion in 2017. Exports were \$125.9 billion; imports were \$110.0 billion. The US goods and services trade surplus with United Kingdom was \$15.9 billion in 2017.

USTR seeks comments on objectives for US-Japan Trade Agreement

On October 26, 2018, the Office of the US Trade Representative (USTR) published in the *Federal Register* a request for comments and notice of public hearing on negotiating objectives for a proposed US-Japan Trade Agreement (announced on October 16, 2018) including US interests and priorities, in order to develop US negotiating positions. You can provide comments in writing and orally at a public hearing. Our aim in negotiations with Japan is to address both tariff and non-tariff barriers and to achieve fairer, more balanced trade.

The deadline for the submission of written comments, and for written notification of your intent to testify, as well as a summary of your testimony at the public hearing November 26, 2018. The Trade Policy Staff Committee (TPSC) will hold a public hearing beginning at 9:30 am on December 10, 2018.

USTR announces GSP a hearing for reviews for several countries

On October 15, 2018, the Office of the US Trade Representative (USTR) published in the *Federal Register* a <u>notice</u> [Docket Numbers USTR–2017–0009, USTR–2013–0013, USTR–2013–0009, USTR–2013–0011, USTR–2013–0004, USTR–2015–0018, USTR–2013–0007, USTR–2013–0014, and USTR–2013–0021] announcing a hearing for the open country practice reviews for which USTR has not held hearings in 2018 regarding compliance with the GSP eligibility criteria of Bolivia, Ecuador, Georgia, Indonesia, Iraq, Thailand, and Uzbekistan. This review will focus on whether:

- (1) Bolivia, Georgia, Iraq, Thailand, and Uzbekistan are meeting the GSP eligibility criterion requiring that a GSP beneficiary country afford workers internationally recognized worker rights;
- (2) Ecuador is meeting the GSP eligibility criterion requiring a GSP beneficiary country to act in good faith in recognizing as binding or in enforcing applicable arbitral awards; and
- (3) Indonesia and Uzbekistan are meeting the GSP eligibility criterion requiring a GSP beneficiary to provide adequate protection of intellectual property rights.

In addition, USTR is announcing a hearing for the ongoing country designation review of Laos. This review will focus on whether Laos meets all the GSP eligibility criteria and should be newly designated as a GSP beneficiary. The notice includes the schedule for submission of public comments and a public hearing.

Deadline for submission of comments, pre-hearing briefs, and requests to appear at the November 29, 2018 public hearing: November 13, 2018 at midnight EDT; The GSP Subcommittee of the Trade Policy Staff Committee (TPSC) will convene a public hearing on the GSP country practice reviews of Bolivia, Ecuador, Georgia, Indonesia, Iraq, Thailand, and Uzbekistan and the country designation review of Laos in Rooms 1 and 2, 1724 F Street NW, Washington, DC 20508, beginning at 10:00 a.m.; Deadline for submission of post-hearing briefs: December 17, 2018 at midnight EDT.

ITC issues 13th Revision to the HTSUS

The US International Trade Commission has issued Revision 13 to the Harmonized Tariff Schedule of he United States. The changes include:

- Deleting Chapter 99, subchapter II, US Note 7 & US Notes 13 through 19
- Adding provisions in Chapter 99 (9902.01.01 through 9902.18.03) to implement tariff exemptions or deductions under the Miscellaneous Tariff Bill Act

Revision 13 also includes all the Revision 12 changes, which derive from a recent proclamation (9771) and 2 recent USTR notices. Revision 12 included:

- General note 4(d) modification;
- Chapters 44 and 63 (Chapter notes and revised subheadings);

- New breakouts for subheading 8517.62;
- subchapter III of chapter 99 of the tariff schedule;
- Note 18(c)(iii) Modified (new solar exclusions added);

ITC institutes investigation to assess USMCA

On October 12, 2018, the US International Trade Commission (ITC) <u>announced</u> that it has instituted an investigation to assess the likely impact of a trade agreement that the President has announced he intends to enter into with Mexico and Canada. The details of the investigation were published in a *Federal Register* <u>notice</u> [Investigation No. TPA–105–003] on October 16, 2018

The investigation, <u>United States-Mexico-Canada Agreement: Likely Impact on the U.S. Economy and on Specific Industry Sectors</u>, was requested by the U.S. Trade Representative in a letter received by the ITC on August 31, 2018.

The <u>Bipartisan Congressional Trade Priorities and Accountability Act of 2015</u> (Pub. L. 114-26, Title I) requires the ITC to prepare a report that assesses the likely impact of the Agreement on the U.S. economy as a whole and on specific industry sectors and the interests of U.S. consumers. The ITC's report, which will be public, is due to the President and the Congress no more than 105 days after the President signs the Agreement, which he can do 90 days after he notifies Congress of his intent to do so. The President notified Congress on August 31, 2018, of his intent to enter into the Agreement.

The ITC will hold a public hearing in connection with the investigation beginning at 9:30 a.m. on November 15, 2018. Requests to appear at the hearing should be filed no later than 5:15 p.m. on October 29, 2018, with the Secretary, U.S. International Trade Commission, 500 E Street SW, Washington, DC 20436. For further information, call 202-205-2000.

The ITC also welcomes written submissions for the record. Written submissions should be submitted at the earliest practical date but no later than 5:15 p.m. on December 20, 2018. All written submissions, except for confidential business information, will be available for public inspection.

BIS seeks approval for procedures for submitting rebuttals and surrebuttals requests for exclusions from sec. 232 tariffs

On October 5, 2018, the Bureau of Industry and Security (BIS) published in the *Federal Register* a <u>request for comments on a proposed information collection request</u> [OMB Control No.: 0694-0141] relating to procedures for submitting rebuttals and surrebuttals requests for exclusions from and objections to the Section 232 national security adjustments of imports of steel and aluminum.

On September 11, 2018, BIS published a second interim final rule, Revisions to the Requirements for Submissions Requesting Exclusions from the Remedies Instituted in Presidential Proclamations Adjusting Imports of Steel into the United States and Adjusting Imports of Aluminum into the United States; and the filing of Objections to Submitted Exclusion Requests for Steel and Aluminum. This second interim final rule that was published by BIS, on behalf of the Secretary, made changes to the two supplements added in the March 19 rule: Supplement No. 1 to Part 705 - Requirements for Submissions Requesting Exclusions from the Remedies Instituted in Presidential Proclamation 9705 of March 8, 2018 Adjusting Imports of Steel Articles into the United States; and to Supplement No. 2 to Part 705 - Requirements for Submissions Requesting Exclusions from the Remedies Instituted in Presidential Proclamation 9704 of March 8, 2018 to Adjusting Imports of Aluminum into the United States.

The proposed collection of information gives US Companies the opportunity to submit rebuttals to objections received on posted exclusion requests and also allows US companies the opportunity to submit surrebuttals for objections they submitted that receive rebuttals under the Section 232 exclusion process.

Adding a rebuttal and surrebuttal process is an important step in further improving the exclusion request and objection process for requesting exclusions from the remedies instituted by the President. These voluntary rebuttals and surrebuttals will allow the US Government to better evaluate whether an exclusion request should be granted based on the information provided in an exclusion request and taking into account any objections to a submitted exclusion 3 request, rebuttals, and surrebuttals. Many commenters on the March 19 rule, referenced above, requested Commerce make this type of a change to ensure that the process was fair and Commerce had all of the relevant information when an objection to an exclusion request received a rebuttal or a surrebuttal was received.

Comments are due December 4, 2018.

Labor seeks information on child labor, forced labor, and forced or indentured child labor in the production of goods in foreign countries

On October 5, 2018, the Labor Department (DOL) published in the *Federal Register* a <u>notice requesting information</u> [Docket Number DOL-2018-0006] for three reports issued by the Bureau of International Labor Affairs (ILAB) regarding child

labor and forced labor in certain foreign countries. Relevant information submitted by the public will be used by DOL in preparing its ongoing reporting as required under Congressional mandates and a Presidential directive. The 2017 Findings on the Worst Forms of Child Labor report (TDA report), published on September 20, 2018, discusses efforts of 132 countries and territories to eliminate the worst forms of child labor over the course of 2017 and assesses whether countries made significant, moderate, minimal, or no advancement during that year. It also suggests actions foreign countries can take to eliminate the worst forms of child labor through legislation, enforcement, coordination, policies, and social programs.

The 2018 edition of the *List of Goods Produced by Child Labor or Forced Labor* (TVPRA List), also published on September 20, 2018, makes available to the public a list of goods from countries that This document is scheduled to be published in the Federal Register on 10/05/2018 and available online at https://federalregister.gov/d/2018-21559, and on govinfo.gov 2 ILAB has reason to believe are produced by child labor or forced labor in violation of international standards. Finally, the *List of Products Produced by Forced or Indentured Child Labor* (EO 13126 List), provides a list of products, identified by country of origin, that DOL, in consultation and cooperation with the Departments of State (DOS) and Homeland Security (DHS), has a reasonable basis to believe might have been mined, produced, or manufactured with forced or indentured child labor. Relevant information submitted by the public will be used by DOL in preparing the next edition of the TDA report, to be published in 2019; the next edition of the TVPRA List, to be published in 2020; and for possible updates to the EO 13126 List as needed.

Submitters of information are requested to provide their submission to DOL's Office of Child Labor, Forced Labor, and Human Trafficking (OCFT) at the email or physical address shown in the notice by 5 p.m. on January 11, 2019.

DHS waives certain laws to build border barriers and roads

On October 11, 2018, the Department of Homeland Security (DHS) published in the *Federal Register* a <u>notice</u> that the DHS Secretary has determined, pursuant to law, that it is necessary to waive certain laws, regulations, and other legal requirements in order to ensure the expeditious construction of barriers and roads in the vicinity of the international land border of the United States in Hidalgo County in the State of Texas.

City of London Police join the National IPR Coordination Center

On October 30, 2018, US Immigration and Custom Enforcement (ICE) <u>announced</u> that the City of London Police (CoLP) became the fifth international law-enforcement agency to join the National Intellectual Property Rights Coordination Center (IPR Center) after leadership from the CoLP and IPR Center signed an agreement. A signing ceremony codifying the agreement was hosted by the ICE Homeland Security Investigations-led IPR Center, which also counts the Mexican Revenue Service, Royal Canadian Mounted Police, Interpol and Europol as international members. The total number of agencies aligned with the joint IP enforcement agency now stands at twenty-four.

The addendum signed today builds on a memorandum of understanding signed by HSI and CoLP in 2015, which established a commitment to share intelligence and effective training practices and raise public awareness of counterfeiting and emerging IP crime trends. HSI offices in London, part of the customs agency's

international operations division, has worked closely with CoLP on several investigations and was a major facilitator in the agreement signed on October 30.

CIT orders publication of final TFTEA drawback regulations by December 17

On October 12, 2018, Judge Jane Restani of the US Court of International Trade (CIT) issued an Order requiring the United States (US Customs and Border Protection (CBP) and the Treasury Department) to issue final regulations implementing the drawback provisions of the Trade Facilitation and Trade Enforcement Act of 2015 (TFTEA) by December 17, 2018. The TFTEA amended the Tariff Act of 1930, as amended, to simplify the filing of drawback claims making them less burdensome for both claimants and CBP. Congress provided Treasury two years from the enactment of the TFTEA to promulgate regulations implementing the TFTEA's drawback amendments. Treasury did not meet the two-year deadline, which lapsed on February 24, 2018. This date also marked the beginning of a transition year, set to end on February 23, 2019, during which drawback claimants could file drawback claims under 19 U.S.C. § 1313, as it was pre-TFTEA, or under that statutory provision as amended by the TFTEA. In lieu of new regulations, CBP published an "interim guidance document" (IGD). The IGD indicates CBP will accept claims filed under the new TFTEA rules, but will not process these claims until implementing regulations are developed by Treasury, published in a NPRM, subjected to notice and comment, edited as necessary, and issued as final rules. {Ed. Note: Although CBP is in the Department of Homeland Security, CBP revenue regulations require approval by Treasury.}

The Order was issued in an action brought by several companies who requested the CIT to direct CBP and Treasury to issue, as an interim final rule ("IFR"), certain regulations recently published as part of a notice of proposed rulemaking ("NPRM"). Of greatest concern to plaintiffs, because regulations implementing the new law were not in place, plaintiffs could not receive payment preliquidation, i.e. accelerated drawback. The Court concluded that an interim final rule was not an appropriate remedy, but that expedited promulgation of a final rule was warranted to prevent continued harm to plaintiffs as members of the importing public. The court ordered that the final rule be published in the *Federal Register* by December 17, 2018, as set forth specifically in the accompanying order. [*Tabacos de Wilson, Inc., et al v. United States, et al.* Slip Op. 18-138 (Ct.. Int'l Trade, October 12, 2018)]

CBP publishes quarterly interest rates

On October 16, 2018, US Customs and Border Protection (CBP) published in the *Federal Register* a general notice that advises the public that the quarterly Internal Revenue Service interest rates used to calculate interest on overdue accounts (underpayments) and refunds (overpayments) of customs duties will remain the same from the previous quarter. For the calendar quarter beginning October 1, 2018, the interest rates for overpayments will be 4 percent for corporations and 5 percent for non-corporations, and the interest rate for underpayments will be 5 percent for both corporations and non-corporations. This notice is published for the convenience of the importing public and CBP personnel. The rates announced in this notice are applicable as of October 1, 2018.

Important CBP ruling on determining country of origin for Section 301 purposes

CBP recently published a ruling that every company considering shifting production from China to Mexico (or Canada) as part of a strategy to mitigate the impact of the Section 301 duties should be aware of. In Headquarters Ruling H300226 (September 13, 2018), CBP concluded that, while the NAFTA Marking Rules (19 C.F.R. Part 102) are used to determine the country of origin of articles imported into the United States from Mexico for marking purposes, the traditional substantial transformation test is used to determine the country of origin of articles for Section 301 duty purposes.

As you will see from the ruling, parts of a motor were imported into Mexico for assembly. The assembly operation in Mexico was sufficient to satisfy the applicable NAFTA Marking Rule, such that the finished article was considered to a "product of Mexico" for marking purposes. CBP, however, then went on to say that the traditional substantial transformation test is used for purposes of "antidumping, countervailing, or other safeguard measures[.]" CBP then applied the traditional substantial transformation test to the facts and concluded that the Mexican assembly operations were not sufficient to confer origin and, therefore, the finished motor imported into the United States was a "product of China" for Section 301 purposes. So, in short, the product had to be marked to indicate that it was of Mexican origin, but the importer had to pay the Section 301 duty applicable to Chinese-origin articles.

This ruling highlights a few important points. First, while the traditional substantial transformation test and the NAFTA Marking Rules are meant to embody the same origin principles, they do not always produce the same result due to the different nature of the tests (i.e., the traditional substantial transformation test is subjective; whereas the NAFTA Marking Rules are objective). Second, for purposes of section 301, the traditional substantial transformation test must be used even if the goods are imported from an FTA-partner country (e.g., Mexico, Canada, Singapore, etc.). The NAFTA Marking Rules may be helpful to that analysis, but are not determinative. Finally, CBP is willing to live with this seemingly absurd result (i.e., an article marked "Product of Mexico" being subject to duties applicable to "products of China").

CBP states that Sec. 301 tariffs may be applied to certain sets, even if the set is classified outside the Sec. 301 subheadings

On September 6, 2018, CBP issued Headquarters (HQ) ruling H299857, a significant information letter upholding a New York ruling interpreting how Section 301 tariffs will be applied to certain retail sets containing only some goods subject to the section 301 additional tariffs. The HQ ruling involved a reconsideration of New York (NY) ruling N298532 (July 26, 2018) which held that a 129-piece Mechanic's toolset is properly classified in 8206.00.00, Harmonized Tariff Schedule of the United States (HTSUS), which provides for "[t]ools of two or more headings 8202 to 8205, put up in sets for retail sale." The general rate of duty applicable to products of subheading 8206.00.00, HTSUS, is "[t]he rate of duty applicable to the article in the set subject to the *highest* rate of duty." In accordance with the application of the duty rate in subheading 8206.00.00 to "[t]he rate of duty applicable to the article in the set subject to the highest rate of duty," NY N298532 considered the duty rate of each article in the set. With respect to the items classified in subheading 8466.10.0175, HTSUS, NY N298532 considered the column one rate of 3.9% duty plus the additional 25% Section 301 tariff. Accordingly, NY N298532 concluded that the rate of duty applicable to the entire set was 28.9%.

HQ concluded that the NY approach was consistent with CBP's policies and past practices. A section 301 FAQ states that:

When importing goods put up in sets for retail sale (in accordance with General Rule of Interpretation 3) that contain articles subject to the Section 301 remedy, if the product that imparts the essential character to the set (i.e. the HTSUS provision under which the entire set is classified) is covered by the Section 301 remedy, then the entire set will be subject to the additional 25% duties. [Emphasis added.]

If the HTSUS provision under which the entire set is classified is not covered by the Section 301 remedies, but the set contains components that are classified in a subheading covered by the 301 list, the 301 duties will not be assessed on the individual components.

HQ pointed out that this rule applies only when GRI 3 is used. Furthermore, the above reasoning is inapplicable to this set since it is unlike other sets where the duty rate used is that of the component that imparts the essential character, here the duty rate is determined based on the article with the highest duty rate and the entire set must be taken into account. CBP stated:

in contrast, the set is classified by reference to GRI 1. See Informed Compliance Publication "Hand Tool Sets Classified Within Subheadings 8205.90.00 and

8206.00.00" ("Subheading 8206.00.00, HTSUS, allows for tools that are put up in sets suitable for retail sale to be classified under this one subheading based on GRI 1 . . ."). This guidance therefore does not address the situation presented. Furthermore, the above reasoning is inapplicable to this set since it is unlike other sets where the duty rate used is that of the component that imparts the essential character, here the duty rate is determined based on the article with the highest duty rate and the entire set must be taken into account.

CBP did not dispute that,

if entered separately, and as mentioned in T.D. 91-7, each item would be subject to the column one rate of duty associated with its tariff classification, with only the items specifically listed in U.S. Note 20(b) of Subchapter III, Chapter 99, HTSUS, subject to the 301 measures. Here, however, the items are entered under 8206.00.00, HTSUS, as part of a set. The entire set is subject to "[t]he rate of duty applicable to the article in the set subject to the highest rate of duty." Here, that article is subject to a 28.9% rate of duty. Therefore, under the plain terms of the provision, the entire set is subject to a 28.9% rate of duty.

HQ affirmed NY N298532.

CBP revises Craft Beverage Modernization and Tax Reform Act procedures

On October 16, 2018, CBP issued <u>CSMS 18-000609 Procedures & Requirements: Implementing Craft Beverage Modernization & Tax Reform of 2017</u> (CBMA), which revises, effective immediately, previous CBP guidance on the CBMA. CSMS 18-000609 addresses the foreign assignment aspect of CBMA for 2018 entries. CBP will issue further communication for 2019 entries at a later date.

CBP will also issue at a later date separate procedures and requirements addressing the CBMA's temporary changes to the tax classification of certain wines, including wines containing more than 14% but not more than 16% alcohol by volume.

Effective immediately, CBP advises importers claiming a reduced tax rate or tax rate incorporating applicable tax credits as permitted by the CBMA (hereinafter "CBMA rate") to do so at the time of entry summary. In addition, going forward, importers will use the CBMA flag to identify entry lines for which the CBMA rate is claimed and declare the lower tax rate (as opposed to the excise tax rate required prior to the enactment of the CBMA). Importers should ONLY use the CBMA flag when claiming the CBMA rate, whether at the time of entry summary filing or the filing of a PSC.

For entries filed since January 1, 2018 that have not liquidated and for which the importer wants to make a CBMA claim, effective immediately:

- A) If not flagged, importers should file a PSC with the CBMA flag and the CBMA rate.
- B) If flagged but the CBMA rate has not been claimed, importers should file another PSC with the CBMA rate and the CBMA flag.

For those importers that have liquidated entries for which they would like to claim the CBMA rate, the importer may file a protest. Importers filing protests claiming the CBMA rate should identify "CBMA" in the protest issue dropdown.

For any entries filed since January 1, 2018, for which the low excise tax rate was claimed, importers must complete the CBMA claim by flagging the entry immediately via PSC, and submitting the substantiating documents, as defined below, prior to CBP review and liquidation. PSC is the mechanism for submitting CBMA claims in this situation if within the PSC timeframe.

The CSMS discusses at length the documentation to complete a CBMA claim that importers are required to file at the time of entry summary, PSC filing or protest filing.

USCG imposes restrictions on entry Iraqi vessels from certain ports

On October 12, 2018, the US Coast Guard (USCG) published in the *Federal Register* a <u>notice</u> [Docket No. USCG–2018–0275] that announces that the USCG will impose conditions of entry (set forth in the notice) on vessels arriving from certain ports in the Republic of Iraq. Conditions of entry are intended to protect the United States from vessels arriving from countries that have been found to have deficient antiterrorism port measures in place. The policy announced in the notice, which will become effective October 26, 2018, will not apply to the Al-Basrah Oil Terminal, the Khor Al Amaya Oil Terminal and Al Maqal Terminal 14 (also known as the North America Western Asia Holdings Facility). At the present time, the following countries do not maintain effective anti-terrorism measures in their ports and are therefore subject to conditions of entry: Iraq, Cambodia, Cameroon, Comoros, Côte d'Ivoire, Equatorial Guinea, The Gambia, Guinea-Bissau, Iran, Liberia, Libya, Madagascar, Micronesia, Nauru, Nigeria, Sao Tome and Principe, Syria, Timor-Leste, Venezuela, and Yemen.

Census updates AES Import Concordance File

The Bureau of Census advises that the <u>AES Import Concordance File</u> has been updated, effective November 1, 2018. The AES Import Concordance File can be found <u>here</u>. For further information or questions, contact the U.S. Census Bureau's <u>Data Collection Branch</u>.

Census announces Schedule B and HTS updated in AES to accept changes from Proclamation 9771; also available for download

Effective immediately, the Schedule B and Harmonized Tariff Schedule (HTS) tables have been updated in the AES to include the recent changes from Presidential Proclamation 9771 published August 2, and effective October 1.

AES will accept shipments with outdated codes during a grace period for 30 days beyond the expiration date. Reporting an outdated code after the 30-day grace period will result in a fatal error.

The ACE AESDirect program has been updated and will accept shipments with outdated codes during the grace period as well.

The <u>Schedule B and HTS tables</u> and the <u>current list of HTS codes that are not valid for AES</u> are available for download.

BIS adds Fujian Jinhua Integrated Circuit Company to Entity List

On October 30, 2018, the Bureau of Industry and Security (BIS) published in the *Federal Register* a <u>final rule</u> [Docket No. 181010930–8930–01] that amends the *Export Administration Regulations* (EAR) by adding one entity, Fujian Jinhua In-

tegrated Circuit Company, Ltd., to the Entity List. The entity that is added to the Entity List has been determined by the U.S. Government to pose a significant risk of becoming involved in activities contrary to the national security or foreign policy interests of the United States. This entity will be listed under the destination of China.

For the one entity added to the Entity List in this final rule, BIS imposes a license requirement for all items subject to the EAR and a license review policy of presumption of denial. In addition, no license exceptions are available for exports, reexports, or transfers (in-country) to the person being added to the Entity List in this rule. The acronym "a.k.a." (also known as) is used in entries on the Entity List to identify aliases, thereby assisting exporters, reexporters and transferors in identifying entities on the Entity List

Shipments of items removed from eligibility for a License Exception or export or reexport without a license (NLR) as a result of this regulatory action that were enroute aboard a carrier to a port of export or reexport, on October 30, 2018, pursuant to actual orders for export or reexport to a foreign destination, may proceed to that destination under the previous eligibility for a License Exception or export or reexport without a license (NLR).

BIS amends EAR to implement Wassenaar Arrangement 2017 Plenary Agreements

On October 24, 2018, the Bureau of Industry and Security (BIS), Commerce, published in the *Federal Register* a final rule [Docket No. 170831854-7854-01] that revises the Commerce Control List (CCL), as well as corresponding parts of the *Export Administration Regulations* (EAR), to implement changes made to the Wassenaar Arrangement List of Dual-Use Goods and Technologies (WA List) maintained and agreed to by governments participating in the *Wassenaar Arrangement on Export Controls for Conventional Arms and Dual-Use Goods and Technologies* (Wassenaar Arrangement, or WA) at the December 2017 WA Plenary meeting. The Wassenaar Arrangement advocates implementation of effective export controls on strategic items with the objective of improving regional and international security and stability. This rule harmonizes the CCL with the agreements reached at the 2017 Plenary meeting by revising Export Control Classification Numbers (ECCNs) controlled for national security reasons in each category of the CCL. This rule also makes other associated changes to the EAR and makes a correction. The rule was effective on publication.

BIS seeks comments of foreign disposition of certain commodities

On October 23, 2018, the Bureau of Industry and Security (BIS), Commerce, published in the *Federal Register* a <u>notice of inquiry</u> [Docket No. 180831812-8812-01; BIS-2018-0022] seeking public comments on the effects and costs that would result if BIS were to amend its regulations to reflect new export authorization requirements regarding electronic waste, including new recordkeeping requirements, reporting requirements, and data elements in the Automated Export System, maintained by the US Census Bureau, to track electronic waste that is exported. Comments from all interested persons are welcome and will help BIS determine the feasibility and cost of implementing a mechanism for tracking and controlling electronic waste exports.

Comments must be received by BIS no later than December 24, 2018.

OFAC designates Iranian entities and banks as Specially Designated Nationals and FinCEN issues advisory on Iran's "Illicit and Malign" activities and attempts to exploit financial systems

On October 16, 2018, the US Treasury Department's Office of Foreign Assets Control ("OFAC") designated certain Iranian entities and banks as Specially Designated Nationals ("SDNs") pursuant to Executive Order ("EO") 13224, which targets terrorists and those providing support to terrorism. A full list of those entities designated as part of this action is available here. US Persons (*i.e.*, entities organized under US laws and their non-US branches; parties physically located in the United States; US citizens and permanent resident aliens wherever located or employed) are prohibited from dealing directly or indirectly with SDNs. Under the Iranian Transactions and Sanctions Regulations ("ITSR"), non-US entities owned or controlled by US Persons are also prohibited from dealing with SDNs that are located or based in Iran (regardless of their reason for designation) or owned or controlled by the Government of Iran (regardless of where they are located).

According to an OFAC <u>press release</u>, the Iranian entities have been designated for their direct or indirect involvement in providing millions of dollars in financial support to the Basij Resistance Force, a paramilitary organization associated with the Iran's Islamic Revolutionary Guard Corps ("IRGC") that allegedly recruits child soldiers. The IRGC is currently designated as an SDN under numerous US sanctions programs.

As a part of these actions, the following Iranian financial institutions previously designated on the Executive Order 13599 List have been moved to the Specially Designated Nationals and Blocked Persons List ("SDN List"): Bank Mellat, Sina Bank (a.k.a. Bonyad Finance and Credit Company, BFCC, and Sina Finance and Credit Company), and Parsian Bank (a.k.a. Bank-E Parsian). Prior to these SDN designations, it was permissible for US Persons and non-US entities owned or controlled by US Persons to deal with these banks in the context of certain types of transactions authorized under the ITSR, such as the general license for the sale and supply of agricultural commodities, medicines, and medical devices to Iran. With the addition of these Iranian banks to the SDN List, parties relying on such general licenses may no longer permit the participation of these banks in their transactions.

In addition, non-US parties dealing with these SDN banks as well as the other Iranian parties designated under EO 13224 could become the target of US secondary sanctions, even for the transactions that occur wholly outside of US jurisdiction (e.g., no US Persons, no US-dollar payments). This US secondary sanctions risk does not apply to non-US parties dealing with persons on the EO 13599 List.

These designations are separate and apart from the US Government's withdrawal from the *Joint Comprehensive Plan of Action* (aka "JCPOA"), which is scheduled for completion by 11:59 pm Eastern on November 4, 2018. As part of this process, OFAC has advised in <u>public guidance</u> that entities on the EO 13599 List will be re-designated as SDNs no later than November 5, 2018. Those JCPOA-related developments are further described in our previous blog posts here and here.

Separately, on October 11, 2018, the US Treasury Department's Financial Crimes Enforcement Network ("FinCEN") issued an <u>advisory</u> about the Iranian

government's "illicit and malign" activities and attempts to exploit the financial system. This advisory is intended to assist US financial institutions to detect potentially illicit Iran-related transactions. The 19-page document is also intended to assist non-US financial institutions in understanding the obligations related to their US correspondent accounts, to avoid US sanctions exposure, and to address anti-money laundering/combating financing of terrorism risks that Iranian activity poses to the international financial system. FinCEN recommends that this advisory be shared with Chief Executive Officers, Chief Operating Officers, Chief Compliance Officers, Chief Risk Officers, AML/BSA Departments, and Legal Departments. FinCEN's press release regarding the advisory is available here.

OFAC extends expiration date of general licenses related to EN+ and RUSAL

On October 12, 2018, the US Treasury Department's Office of Foreign Assets Control ("OFAC") further extended by one month until December 12, 2018 the expiration dates of three general licenses related to EN+ Group plc and United Company RUSAL PLC ("RUSAL"). RUSAL is one of the world's largest aluminum producers and was previously designated as a Specially Designated National ("SDN") on April 6, 2018 for being owned or controlled, directly or indirectly, by the EN+ Group and the Russian oligarch, Oleg Deripaska. Please see our blog post on the original designation here. The Treasury Department press re-lease indicates that the extension reflects still ongoing discussions with EN+ and RUSAL regarding substantial corporate governance changes that could significantly reduce Deripaska's control. Today's move is a welcome further temporary reprieve for the global aluminum industry as RUSAL seeks to extricate itself from the impact of US sanctions.

The specific extensions are as follows:

- General License 13D, authorizing certain transactions necessary to divest or transfer debt, equity, or other holdings in EN+ Group PLC, GAZ Group, and RUSAL, was reissued as <u>General License 13E</u> and now expires on December 12, 2018 rather than November 12, 2018 for transactions involving EN+ Group PLC or RUSAL or entities 50% or more owned by EN+ Group PLC or RUSAL (the expiration date with respect to GAZ Group, October 23, 2018, remains unchanged).
- General License 14A, authorizing certain activities necessary for the maintenance or wind down of operations or existing contracts with RUSAL or any other entity 50% or more owned by RUSAL, was reissued as General License 14B and now expires on December 12, 2018 rather than November 12, 2018.
- General License 16A, authorizing certain activities necessary to maintenance or wind down of operations or existing contracts with EN+ Group PLC or JSC EuroSibEnergo or any entities 50% or more owned by EN+ Group PLC or JSC EuroSibEnergo, was reissued as General License 16B and now expires on December 12, 2018 rather than November 12, 2018.

Treasury issues interim rule regarding foreign investments in the US

On October 11, 2018, the Treasury Department's Office of Investment Security (OIS) published in the *Federal Register* an <u>interim rule</u> that sets forth amendments to the regulations in part 800 of 31 C.F.R. that implement, and make updates consistent with, certain provisions of the *Foreign Investment Risk Review Modernization Act of 2018* (FIRRMA). Among other things, this interim rule implements certain provisions of FIRRMA that became immediately effective upon its enactment and provides clarity as to the current process and procedures with respect to the reviews and investigations undertaken by the Committee on Foreign Investment in the United States (CFIUS) pursuant to part 800, in light of FIRRMA. The rule went into effect upon publication, but written comments may be submitted but must be received by November 10, 2018.

Treasury establishes CFIUS pilot to review certain transactions involving foreign persons and critical technologies

On October 11, 2018, the Treasury Department's Office of Investment Security (OIS) published in the *Federal Register* an <u>interim rule</u> [31 C.F.R. Part 801] that sets forth the scope of, and procedures for, a pilot program of the Committee on Foreign Investment in the United States (CFIUS) under section 721 of the *Defense Production Act of 1950*, as amended by the *Foreign Investment Risk Review Modernization Act of 2018* (FIRRMA). Pursuant to section 1727(c) of FIRRMA, this pilot program implements the authorities provided in two sections of FIRRMA that did not take effect upon the statute's enactment. First, the pilot program expands the scope of transactions subject to review by CFIUS to include certain investments involving foreign persons and critical technologies. Second, the pilot program makes effective FIRRMA's mandatory declarations provision for all transactions that fall within the specific scope of the pilot program. The pilot program is temporary and will end no later than March 5, 2020. These provisions are effective November 10, 2018.

Except as otherwise provided in §801.103(b) and part 801, the interim regulations apply from the pilot program effective date. The regulations do not apply to any transaction for which: (1) The completion date is prior to the pilot program effective date; or (2) The following has occurred before October 11, 2018: (i) The parties to the transaction have executed a binding written agreement or other document establishing the material terms of the transaction; (ii) A party has made a public offer to shareholders to buy shares of a pilot program US business; or (iii) A shareholder has solicited proxies in connection with an election of the board of directors of a pilot program US business or has requested the conversion of convertible voting securities.

Written comments must be received by November 10, 2018.

DDTC wants industry testers for new registration and advisory opinion application

On October 15, 2018, the Directorate of Defense Trade Controls (DDTC) <u>posted on a website</u> a notice stating that Test versions of DDTC's new Registration and Advisory Opinion (AO) applications, housed on the cloud-based Defense Export Control and Compliance System (DECCS), will be available for industry testing and feedback starting October 16th through mid-November 2018. The posting states:

If you are interested in participating in testing, please contact the DDTC Test Support Team at the number or email below to sign up and receive further guidance. Please note that in order to participate each individual tester will be required to sign a DECCS UAT Terms of Use document to ensure users understand the testing process and guidelines.

We encourage you to begin the testing process as early in the test period as possible. Additional applications will be available for testing in the coming weeks and will require a test account and a complete test registration in order to access them.

State publishes CAATSA sanctions determination

On October 5, 2018, the Department of State published in the *Federal Register* a document [Public Notice 10579] providing notice that State had determined, pursuant to *Countering America's Adversaries Through Sanctions Act of 2017* (CAATSA) Section 231(a), that the Chinese entity Equipment Development Department of the Central Military Commission (EDD), formerly known as the General Armaments Department (GAD), has knowingly, on or after August 2, 2017, engaged in a significant transaction with a person that is part of, or operates for or on behalf of, the defense or intelligence sectors of the Government of the Russian Federation. The Secretary of State has selected certain sanctions to be imposed upon EDD and Li Shangfu, EDD's Director, who has been determined to be a principal executive officer of EDD, or to perform similar functions with similar authorities as such an officer. Please see our Sanctions Blog for details.

State issues interim rule revising ITAR

On October 4, 2018, in response to public comments on regulatory reform, the Department of State published in the *Federal Register* an <u>interim final rule and request for comments</u> [Public Notice 10349] removing certain notification requirements from the *International Traffic in Arms Regulations* (ITAR) and revising several entries on the United States Munitions List to remove items that do not warrant continued inclusion. Specifically, the rule adds notes to USML Category IV and V, revises control text in USML Categories VIII, XI and XV, and revises a section of the regulations. Although the rule was effective on publication, comments may be filed by November 19, 2018.

Restrictive measures and additions to OFAC, State BIS blocking orders, designations, sanctions and entity lists

CITA seeks comments on KORUS commercial availability request

On October 16, 2018, the Committee for the Implementation of Textile Agreements (CITA) published in the *Federal Register* a <u>request for public comments</u> concerning a request for modification of the *US-Korea Free Trade Agreement* (KORUS) rules of origin for certain textile and apparel products.

The Government of the United States received a request from the Government of Korea, submitted on September 24, 2018, to initiate consultations under the KORUS. The Government of Korea is requesting that the United States and Korea ("the Parties") consider revising the rules of origin for certain yarns, woven fabrics, and knit apparel to address availability of supply of fibers and yarns in the territories of the Parties. The President of the United States may proclaim a modification to the KORUS rules of origin for textile and apparel products after the United States reaches an agreement with the Government of Korea on a modification under the KORUS to address issues of availability of supply of fibers, yarns, or fabrics in the territories of the Parties. CITA is soliciting public

comments on this request, in particular with regard to whether certain fibers, yarns, and knit fabrics can be supplied by the US domestic industry in commercial quantities in a timely manner. The fibers and yarns subject to this request, and their specific end-uses, are described in the *Federal Register* notice.

Comments must be submitted by November 16, 2018.

CITA publishes the new 12-month cap on duty- and quota-free benefits

On October 1, 2018, the Committee for the Implementation of Textile Agreements (CITA) published in the *Federal Register* a document setting forth the new 12-month cap on duty- and quota-free benefits for certain textile and apparel articles imported from designated beneficiary sub-Saharan African countries. Section 112(b)(3) of the *Trade and Development Act of 2000* (TDA 2000) provides duty- and quota-free treatment for apparel articles wholly assembled in one or more beneficiary sub-Saharan African countries from fabric wholly formed in one or more beneficiary sub-Saharan African countries from yarn originating in the United States or one or more beneficiary sub-Saharan African countries. This preferential treatment is also available for apparel articles assembled in one or more lesser-developed beneficiary sub-Saharan African countries, regardless of the country of origin of the fabric used to make such articles, subject to quantitative limitation. P.L. 114-27 extended this special rule for lesser-developed countries through September 30, 2025.

For the one-year period, beginning on October 1, 2018, and extending through September 30, 2019, the aggregate quantity of imports eligible for preferential treatment under these provisions is 2,048,357,135 square meters equivalent. Of this amount, 1,024,178,567 square meters equivalent is available to apparel articles imported under the special rule for lesser-developed countries. Apparel articles entered in excess of these quantities will be subject to otherwise applicable tariffs.

On October 19, 2018, Enforcement and Compliance, International Trade Administration, Commerce, published in the *Federal Register* a <u>document</u> [Docket No. ITA-2018-0002] seeking public comment on any subsidies, including stumpage subsidies, provided by certain countries exporting softwood lumber or softwood lumber products to the United States during the period January 1, 2018, through June 30, 2018.

Section 805 of Title VIII of the *Tariff Act of 1930* (the *Softwood Lumber Act of 2008*) requires Commerce to submit to the appropriate Congressional committees a report every 180 days on any subsidy provided by countries exporting softwood lumber or softwood lumber products to the United States, including stumpage subsidies. Commerce submitted its last subsidy report on June 20, 2018. As part of its newest report, Commerce intends to include a list of subsidy programs identified with sufficient clarity by the public in response to this notice.

Given the large number of countries that export softwood lumber and softwood lumber products to the United States, Commerce is soliciting public comment only on subsidies provided by countries whose exports accounted for at least one

percent of total US imports of softwood lumber by quantity, as classified under *Harmonized Tariff Schedule* code 4407.1001 (which accounts for the vast majority of imports), during the period January 1, 2018, through June 30, 2018. See the notice for definitions of a subsidy and other information.

Comments must be submitted within 30 days after publication of the notice.

India submits Semi-Annual Report on Anti-Dumping Actions

In pursuance of Article 16.4 of the *Agreement on Implementation of Article VI of the General Agreement on Tariffs and Trade 1994*, India notified the Committee on Anti-Dumping Practices regarding Anti-Dumping actions for the period 1 January, 2018 to 30 June, 2018, reproduced vide Notification No. G/ADP/N/314/IND (dated 4 October, 2018). Subsequently, corrigendum to modify the Semi-Annual Report was circulated vide Notification No. G/ADP/N/314/IND/Corr.1 (dated 11 October, 2018).

Member States question India regarding State Trading Enterprises

On 8 October, 2018 Canada questioned India on non-submission of notification concerning State Trading Enterprises (STEs) since November, 2012 despite developments in procurement, import and export of pulses, circulated by the Working Party on State Trading Enterprises vide Notification No. G/STR/Q1/IND/17 (dated 9 October, 2018).

INDONESIA

Safeguard investigation on aluminium foil launched

On 12 October 2018, the WTO <u>announced</u> that Indonesia notified the WTO's Committee on Safeguards that it initiated on 9 October 2018 a safeguard investigation on aluminium foil.

In the notification, Indonesia indicated, among other things, as follows:

- (i) Those having substantial interest and wishing to be considered as interested parties in this investigation should submit written request within a period of 15 days in Indonesia from the date of initiation to the Investigating Authority. All submissions and request made by interested parties must be sent both in written letter and in electronic format, and must indicate the name, address, e-mail address, telephone and fax number of the interested parties.
- (ii) In Accordance with article 3.1 WTO Agreement on Safeguard, the Government of the Republic of Indonesia will conduct a hearing in order to provide opportunities for those Members who having a substantial interest to present their evidence and views, Hearing is scheduled to be held on Monday, 29 October 2018 at 10.00-12.00 am. All interested parties, who wish to participate in the hearing and present their evidences and views, should submit related documents to the Investigating Authority not later than 25 October 2018. Registration on the day of the hearing (29 October 2018) will start at 09.00 am and only authorized representatives will have access to the hearing."

MALAYSIA

Is Malaysia Back on Track with the CPTPP?

Following the unexpected victory of the Mahathir-led coalition party in the Malaysian general elections in May 2018, the 60-year uninterrupted rule of the Barisan National came to a historical halt, ending with it many policies and initiatives previously undertaken by the Najib-led administration. In the firing line, stood the CPTPP, in respect of which Mahathir had briefly announced in early June 2018 the potential need for Malaysian to review its participation in the same during his maiden visit to Japan after taking office as the premier, citing the need to consider the terms of the CPTPP vis-a-vis 'the level of development of a country'. The months ensuing the no less than ambiguous statement saw critics from both flanks voicing their sentiments on the CPTPP whilst Malaysia's participation in the same remains uncertain.

Fast forward to late August 2018, following an interview with a Thai television network, Mahathir signaled that Malaysia will press on with ratifying the CPTPP. However, the jubilation for businesses and negotiators alike was only short-lived when in late September 2018, Mahathir was reported to state that Malaysia is still looking at the pros and cons of the CPTPP and, as such, has yet to make any final decision on the trade pact citing key concerns such as the potential impact of the ISDS mechanism (which, briefly, allows private stakeholders to have direct recourse against CPTPP member states in the event of a dispute) as well as the potential anti-Chinese outlook of the CPTPP.

At the current pace, Malaysia is unlikely to be at the forefront to reap the benefits of the CPTPP, which is tentatively expected to enter into force late 2018 / early 2019 once at least 6 countries out of the 11 signatories have notified the CPTPP Depositary in writing of the completion of their domestic ratification process. At this juncture, Mexico, Japan and Singapore have ratified the CPTPP domestically and Australia, Canada, Chile, New Zealand and Vietnam are expected to complete their respective internal ratification processes by the end of 2018 following updates shared by CPTPP member states .

If Malaysia decides not to join the CPTPP, Malaysia will risk losing its competitive edge as the preferred foreign investment destination vis-a-vis its ASEAN contemporaries such as Vietnam and Singapore. Hopeful businesses in Malaysia will

also lose out on the opportunity to gain new market access to Canada, Peru and Mexico that businesses in Malaysia would be able to take advantage of under the CPTPP.

At this stage, the business community can only patiently wait for a clearer signal from the Malaysian government as to whether Malaysia will join the CPTPP free trade wave and ride against the tide of nationalistic global trend worldwide as observed from the historical hallmarks of Brexit, Trump's withdrawal from the CPTPP and the US-China trade war.

NEW ZEALAND

New Zealand becomes the fourth signatory to ratify CPTPP

On 25 October 2018, New Zealand formally <u>ratified</u> the *Comprehensive and Progressive Agreement for the Trans-Pacific Partnership* (CPTPP) bringing the number of ratifications to four. Subsequently, Canada and Australia deposited their notifications of ratification, bringing the number to six, the number required to enter into force, which will now happen on 30 December.

New Zealand is first country to ratify PACER Plus trade deal

On 24 October 2018, the New Zealand Government <u>announced</u> that it was the first country to complete its domestic procedures to ratify the *Pacific Agreement* on *Closer Economic Relations* (PACER Plus) trade and development agreement. It builds on existing trade agreements: the *South Pacific Regional Trade and Economic Cooperation Agreement* (SPARTECA) (1980) and the original *PACER Agreement* (2001).

PACER Plus is a trade and development agreement that will lower barriers, provide greater certainty for NZ businesses, and raise living standards, create jobs and increase exports in Pacific Island countries. The intended benefits of PACER Plus are:

- a more predictable trading environment
- more consistent and transparent rules throughout the region on sanitary and phytosanitary measures, technical barriers to trade, and customs procedures
- more liberal and product-specific rules of origin
- increased investment in the region, in particular by New Zealand and Australian investors into Pacific Island countries
- greater certainty around tariffs for exporters
- more opportunities for trade-related development assistance for Pacific Island countries
- a more mobile labour force in the region.

PACER Plus comes into force 60 days after at least eight of the eleven signatories have ratified. The other signatories are: Australia, the Cook Islands, Kiribati, Nauru, Niue, Samoa, the Solomon Islands, Tonga, Tuvalu and Vanuatu.

Changes to import requirements for some explosives

Following public consultation earlier this year, the Environmental Protection Authority (EPA) has changed the import requirements for some explosives.

From 1 October 2018, importers of certain items containing explosives will NOT require an import permit from the EPA. These items include:

- · Party poppers,
- Christmas crackers,
- · Cap guns,
- · Marine (ship) flares and
- · Railway signals

Fireworks and other explosives will continue to require the import permit.

SINGAPORE

Singapore Customs posts changes to the prohibition of imports, exports, transshipments and goods in transit from or to North Korea

On 16 October 2018, Singapore Customs posted <u>Circular No. 10/2018</u> which announces updated regulations governing the prohibition of imports, exports, transshipments and goods in transit from or to the Democratic People's Republic of Korea (DPRK or North Korea).

Under Regulation 6(1)(b) of the <u>Regulation of Imports and Exports Regulations</u>, the importation into, exportation from, or transhipment or transit through Singapore of any goods which will contravene the decisions of the United Nations Security Council (UNSC) in resolutions made under Chapter VII of the United Nations Charter, are prohibited.

With the adoption of UNSC Resolution 2397 (2017), Singapore has updated the Seventh Schedule, read with Regulation 6(2)(d) of the *Regulation of Imports and Export Regulations* to allow traders to more easily refer to the various trade prohibitions imposed by the decisions made by the UNSC. The updated prohibitions have been published in the *Regulation of Imports and Exports (Amendment) Regulations 2018*, which take effect on 17 Oct 2018.

Traders are reminded that the import, export, transhipment, and transit of any goods that are for the purposes of trade with any person in the DPRK continue to be prohib-

For goods which are not for the purposes of trade, which are imported from, exported or re-exported to the DPRK, traders would need to apply for a TradeNet® permit at least 3 working days before the intended date of shipment. Supporting documents should include documents to show that the shipment is non-commercial in nature (e.g. a letter of authorisation issued by a United Nations (UN) body). Please be reminded to comply with all the conditions stipulated in the approved permits.

Penalties

Under the <u>Regulation of Imports and Exports Act</u> (RIEA), any person who contravenes any of these prohibitions shall be guilty of an offence and shall be liable to –

- a) a fine of not exceeding S\$100,000 or 3 times the value of the goods in respect of which the offence was committed, whichever is the greater, or to imprisonment for a term not exceeding 2 years or to both, on the first conviction; and
- b) a fine of not exceeding \$\$200,000 or 4 times the value of the goods in respect of which the offence was committed, whichever is the greater, or to imprisonment for a term not exceeding 3 years or to both, on the second or subsequent conviction

Singapore Customs implements Revised Rules of Origin and Operational Certification Procedures under the India-Singapore CECA

Singapore Customs <u>Circular 09/2018</u> of 7 September 2018 outlines the changes and new requirements in the revised *India-Singapore Comprehensive Economic Cooperation Agreement* (CECA) Rules of Origin (ROO) and Operational Certification Procedures (OCP) for exports to India, which will take effect from 14 September 2018. VIETNAM

Compulsory use of e-invoices from 1 November 2020

As an effort to mitigate tax evasion and reinforce tax administration, the Government issued Decree No. 119/2018/ND-CP ("Decree 119") dated 12 September 2018, effective on 1 November 2018 to regulate the use of e-invoices, as a replacement for paper invoices, by business entities in Vietnam.

Under Decree 119, companies must use e-invoices for selling goods or rendering services as the proof of transaction/payment. Though e-invoices can be converted to paper invoices, the "converted" paper invoices only hold the value of bookkeeping under accounting law, except for paper invoices created by billing machines which are electronically connected with the tax authorities for data

Commission releases report on EU trade agreements

On 31 October 2018, the European Commission issued its second annual Report on Implementation of EU Free Trade Agreements, covering calendar year 2017. According to the report the agreements, which cover nearly 70 markets all over the world, are proving effective in removing barriers to trade and promoting high standards of labour and environment protection. However, European exporters could make even more out of the opportunities offered by the agreements in place. A press release issued by the Commission stated in part:

Today's report covers developments in 2017 and shows that trade under existing EU trade agreements keeps growing. To give a few examples, exports to South Korea increased by over 12% last year, exports to Colombia by more than 10%, and EU exports to Canada rose by 7% in the nine months following the entry into force of the EU-Canada agreement. EU agri-food producers are among the main beneficiaries of scrapped customs duties, with strong export increases last year especially to Ecuador (+34%), Chile (+29%), Serbia (+23%), Turkey and Costa Rica (both +14%).

As regards regulatory obstacles to trade, EU trade agreements last year made it possible to open the Mexican market to European health products, while also opening the Chilean and Peruvian markets to some EU agri-food exports, and paved the way for EU companies to bid in public tenders in Georgia, Moldova and Ukraine.

When it comes to the promotion of EU standards and sustainable development, thanks to specific provisions in EU trade agreements, partners such as Canada and Mexico ratified International Labour Organisation Conventions last year, offering greater protection to workers.

Despite these positive developments, more could still be achieved if EU companies made full use of the opportunities available under the agreements in place. For that reason, together with Member States and business networks, the Commission is boosting its efforts to inform and help EU companies, especially smaller ones, to benefit from trade deals. Initiatives include improving online tools such as the Market Access Database and the Trade Helpdesk, and providing step-by-step guidance to businesses that want to make the most out of the recent EU trade agreements with Canada and Japan.

Commission publishes the 2019 version of the Combined Nomenclature

The European Commission has published the latest version of the Combined Nomenclature (CN) applicable as from 1 January 2019.

The Combined Nomenclature forms the basis for the declaration of goods (a) at importation or exportation or (b) when subject to intra-Union trade statistics. This determines which rate of customs duty applies and how the goods are treated for statistical purposes. The CN is thus a vital working tool for business and the Member States' customs administrations.

The Combined Nomenclature was established by Council Regulation (EEC) No 2658/87 on the tariff and statistical nomenclature and on the Common Customs

Tariff. It is updated every year and is published as a Commission Implementing Regulation in the Official Journal of the European Union, L Series.

The latest version is now available as <u>Commission Implementing Regulation</u> (EU) 2018/1602 in EU *Official Journal* L 273 of 31 October 2018 and applies from 1 January 2019. The latest version includes:

- Amendments to implement the gradual reduction of duty rates for fresh bananas, as required by Council Decision 2011/194/EU;
- Amendments to implement the gradual reduction of duty rates for products covered by the agreement in the form of the Declaration on the Expansion of Trade in Information Technology Products (ITA2), as required by Council Decision (EU) 2016/971:
- Amendments to take account of changes in requirements relating to statistics, to commercial policy and technological and commercial developments, by deleting obsolete codes, by introducing new subheadings to facilitate monitoring of specific goods;
- Amendments to adapt the list of international non-proprietary names (Annex 3 to Section II of Part Three (Tariff Annexes) of the CN) and the list of pharmaceutical intermediates, i.e. compounds of a kind used for the manufacture of finished pharmaceutical products (Annex 6 to Section II of Part Three (Tariff Annexes) of the CN), which are free of duty;
- New CN codes to better monitor the growing market of 'beverage can body stock', 'beverage can end stock and tab stock', under subheading 7606 12 and to definitions of these products under a new Additional note 2 to Chapter 76; and
- Certain minor changes in order to align the different language versions of the text.

EU and Singapore forge closer economic and political ties

On 19 October 2018, the European Commission <u>announced</u> that the European Union and Singapore have signed three agreements, taking their political, trade, and investment relations to a new level. The agreements signed are the EU-Singapore Trade Agreement, the EU-Singapore Investment Protection Agreement and the Framework Agreement on Partnership and Cooperation. Together, they signify an important step towards increasing the EU's presence in a fast-growing, important region. The announcement said in part:

The trade agreement with Singapore will remove nearly all remaining tariffs on certain EU products, simplify customs procedures and set high standards and rules. It simplifies trade in goods like electronics, food products and pharmaceuticals, while stimulating green growth. It opens up the market for services like telecommunications, environmental services and engineering. It also includes a comprehensive chapter on trade and sustainable development, setting the highest standards of labour, safety, environmental and consumer protection, as well as strengthening joint actions on sustainable development and climate change.

The Investment Protection Agreement contains all aspects of the EU's new approach to investment protection and its enforcement mechanisms. It will ensure a high level of investment protection, while safeguarding the EU's and Singapore's rights to regulate and pursue public policy objectives such as the protection of public health, safety and the environment.

The trade and investment agreements represent the first building block towards a future region-to-region agreement between the EU and ASEAN.

The Framework Agreement on Partnership and Cooperation, signed by the High Representative/Vice-President Federica Mogherini and her counterpart, the Minister of Foreign Affairs of Singapore, Vivian Balakrishnan, will allow the EU and Singapore to strengthen political, economic and sectoral cooperation across a wide range of fields,

including environment, climate change, energy, education and culture, employment and social affairs, science and technology, transport, counter terrorism and the fight against organised crime. It will enhance cooperation on global challenges, where both Singapore and the EU play an increasingly important role, and will help address them in a more coherent way. The Agreement establishes a Joint Committee, which will ensure the proper functioning and implementation of the Agreement.

The Partnership and Cooperation Agreement with Singapore is the fourth such agreement signed with an ASEAN country, following the agreements with Indonesia, the Philippines and Vietnam. It will supersede the current legal framework of the 1980 Cooperation Agreement between the European Economic Community and member countries of ASEAN.

Next steps

The trade and investment agreements will be sent to the European Parliament for consent. The trade agreement could then enter into force before the end of the current mandate of the European Commission in 2019, while the investment protection agreement will also follow ratification procedures at Member States level. The Partnership and Cooperation Agreement will need to be ratified by EU Member States and submitted to the European Parliament before it enters formally into force.

Council authorises launch of beef negotiations with US

On 19 October 2018, the European Council <u>announced</u> that it has authorised the Commission to open negotiations on an agreement with the United States on imports of high quality beef from animals not treated with certain growth promoting hormones. The announcement said:

The Council also adopted a mandate for the negotiations, which will review the functioning of the existing quota for imports of hormone-free beef into the EU. Hormone-free beef imports are not part of the wider discussions on improving EU-US trade relations launched following the 25 July meeting between Presidents Juncker and Trump. Nevertheless, finding a mutually beneficial solution to our longstanding dispute over beef would be a major step forward in improving our trade cooperation.

The aim of the negotiations will be to settle definitively a long-standing WTO dispute. It is not meant to affect in any way the EU ban on hormones-treated beef as such. The ban remains. The EU and the United States agreed on an interim solution in 2009, later revised in 2014, which grants a tariff rate quota (TRQ) for hormone-free beef imports of 45 000 tons. In line with WTO rules, this TRQ is also available to exporters from other WTO member countries. A review of the existing arrangements was requested by the previous US Administration in 2016, and the two sides have since explored possible solutions.

The aim of the negotiations is to find a mutually satisfactory solution in line with WTO rules. The Commission is not authorised to negotiate an increase in the existing TRQ but can discuss a country-specific allocation of the overall quota. Negotiations with other supplying countries may be needed to ensure that any agreed country-specific allocation with the US respects their existing rights under the WTO/GATT Agreements.

EFTA-US meet for fifth trade political dialogue

The European Free Trade Association (EFTA) Secretariat <u>announced</u> that an EFTA delegation met with representatives from US agencies, including the Assistant Trade Representative in Washington DC on 17 October. The announcement said:

The fifth meeting in the EFTA-US Trade Policy Dialogue covered technical barriers to trade as well as current developments in trade policy. These include the USMCA Agreement, developments in the WTO and the tariff measures enacted by the US on steel and aluminium as well as against certain Chinese imports. The discussions also

covered the possible implications of Brexit for the US and for the EFTA States and trade talks between the EU and the US.

The purpose of the EFTA-US Trade Policy Dialogue established in 2013 is to foster greater mutual understanding on trade policy between EFTA and the US and explore possible avenues for further cooperation and closer trade relations between the two sides.

2018 Update of the EU Control List of Dual-Use Items

The European Commission <u>announced</u> that on 10 October 2018, the Commission adopted the annual Delegated Regulation that updates the EU dual-use export control list in Annex I to Regulation (EC) No 428/2009 and brings it in line with the decisions taken within the framework of the international non-proliferation regimes and export control arrangements in 2017.

The majority of the changes this year result from amendments that were agreed at the 2017 Plenary of the Wassenaar Arrangement, including:

- Change of controls on measuring and inspection equipment (2B006) and now including angular measuring equipment;
- Deletion of control on robots with 3D image processing (2B007a);
- Deletion of controls on technology for numerical control units (2E003b) and machine tool instruction generators (2E003d);
- New control entry for electro-optic modulators (3A001i); o New entry for semiconductor manufacturing mask substrate blanks (3B001j); o New decontrols for 'upgrade' intrusion software (4D004);
- New decontrol for technology for 'vulnerability disclosure' and 'cyber incident response' (4E001);
- New control for Focal Plane Array (FPA) readout integrated circuits (ROIC) (6A002f); o Deletion of controls on high speed cinema film recording and mechanical cameras (6A003a);
- New parameter for 'corrected specific fuel consumption' added to the control on marine gas turbine control (9A002);
- Increase of controls for ground based spacecraft control equipment (9A004);
 o Change of software controls for testing aero gas turbines engines (9D004b).

The Missile Technology Control Regime in 2017 decided to add new parameters for controls on batch and continuous mixers (1B117), to limit the scope of control for flow-forming machines (2B109) to missile production, to amend the control on satellite navigation systems (7A105) to include regional as well as global systems and to add dry weight and rotor diameter parameters for the control on turbojet/fan engines (9A101).

The Nuclear Suppliers Group agreed in 2017 to add a new control for lithium target assemblies (1B235) to reflect the dual-use NSG entry 2.A.4, and to delete controls for water hydrogen sulphide exchange tray columns (1B229).

The Australia Group in 2017 agreed to add a CWC schedule organic molecule to 1C350, re-write control on genetic elements and make certain additions to the controls on both chemical and biological manufacturing equipment.

The Commission Delegated Regulation will enter into force upon its publication approximately 2 months after its adoption, provided that the Council and the European Parliament raise no objections within this period. The planned publication date, in case of successful completion of the non-objection period, is foreseen for 14 December 2018.

Chemical weapons: the Council of the EU adopts a new sanctions regime

On 15 October 2018, the Council of the EU <u>announced</u> that it had adopted a new regime of restrictive measures to address the use and proliferation of chemical weapons. This decision is a direct follow-up to the <u>conclusions</u> of the European Council of 28 June 2018. The announcement stated:

The EU will now be able to impose sanctions on persons and entities involved in the development and use of chemical weapons anywhere, regardless of their nationality and location.

The restrictive measures target persons and entities who are directly responsible for the development and use of chemical weapons as well as those who provide financial, technical or material support, and those who assist, encourage or are associated with them.

Sanctions consist of a travel ban to the EU and an asset freeze for persons, and an asset freeze for entities. In addition, EU persons and entities are forbidden from making funds available to those listed.

This decision contributes to the EU's efforts to counter the proliferation and use of chemical weapons which poses a serious threat to international security. It supports the global prohibition of chemical weapons as laid down by the Chemical Weapons Convention, against a background of increasing chemical attacks in various parts of the world.

The new regime has been introduced by <u>Council Decision (CFSP) 2018/1544</u> and <u>Council Regulation (EU) 2018/1542</u>.

A <u>press release</u> published by the UK Foreign and Commonwealth Office on 14 October 2018 states that the UK will push for listings under the new regime of "specific individuals and entities responsible for the use and proliferation of chemical weapons across the world". The press release also states that the UK Foreign Secretary will push for an acceleration of discussions on a new EU cyber-related sanctions regime.

Commission implements temporary suspension of duties on certain aircraft goods

On 12 October 2018, the *Official Journal* published <u>Commission Implementing</u> Regulation (EU) 2018/1517 of 11 October 2018 laying down detailed rules implementing certain provisions of Council Regulation (EU) 2018/581 temporarily suspending the autonomous Common Customs Tariff duties on certain goods of a kind to be incorporated in or used for aircraft. Under Regulation (EU) 2018/581, the Commission is required to establish a list of those goods by reference to their Combined Nomenclature codes. The list of headings, subheadings and codes of the Combined Nomenclature, as set out in Annex I to Council Regulation (EEC) No 2658/87 of goods which benefit from the duty suspension laid down in Article 1(1) of Regulation (EU) 2018/581 is laid down in Annex I to the Implementing Regulation.

In addition, it is a condition that a certain type-certificate such as a European Aviation Safety Agency (EASA) Form 1 authorised release certificate or an equivalent is made available to the customs authorities. EASA has concluded bilateral aviation safety agreements or technical working arrangements with certain third countries issuing such types of certificates. Certificates issued by those countries are set forth in Annex II of the Implementing Regulation and will be considered to be equivalent to EASA Form 1.

Council adopts tougher money laundering rules

On 11 October 2018, the Council <u>announced</u> that it had adopted a new anti money laundering directive. This directive introduces new criminal law provisions which will disrupt and block access by criminals to financial resources, including those used for terrorist activities.

The new rules include:

- establishing minimum rules on the definition of criminal offences and sanctions
 relating to money laundering. Money laundering activities will be punishable by a
 maximum term of imprisonment of 4 years, and judges may impose additional
 sanctions and measures (e.g. temporary or permanent exclusion from access to
 public funding, fines, etc.). Aggravating circumstances will apply to cases linked
 to criminal organisations or for offences conducted in the exercise of certain professional activities.
- the possibility of holding legal entities liable for certain money laundering activities which can face a range of sanctions (e.g. exclusion from public aid, placement under judicial supervision, judicial winding-up, etc.)
- removing obstacles to cross-border judicial and police cooperation by setting common provisions to improve investigations. For cross-border cases, the new rules clarify which member state has jurisdiction, and how those member states involved cooperate, as well as how to involve Eurojust.

Once the directive is published in the *Official Journal of the EU*, member states have up to 24 months to transpose it into national law.

This directive complements, on the criminal law aspects, the <u>directive on the prevention of the use of the financial system for the purposes of money laundering</u> or terrorist financing which was formally adopted in May 2018.

Commission publishes WCO 61st HSC outcomes

On 25 October 2018, the *Official Journal* published <u>Communication in accordance with Article 34(7)(a)(iii) of Regulation (EU) No 952/2013 of the European Parliament and of the Council, on decisions relating to binding information issued by the customs authorities of the Member States concerning the classification of goods in the customs nomenclature (2018/C 385/01).</u>

The customs authorities shall revoke decisions relating to binding information from this day if they become incompatible with the interpretation of the customs nomenclature as a result of the following international tariff measures:

- Classification Decisions,
- Classification Opinions or
- amendments to the Explanatory Notes of the Nomenclature of the Harmonised Commodity Description and Coding System,

The European Community has created the Binding Tariff Information (BTI) system as a tool to assist economic operators to obtain the correct tariff classification for goods they intend to import or export.

Binding Tariff Information is issued on request to economic operators by the customs authorities of the Member States. It is valid throughout the Community,

regardless of the Member State which issued it. For information about an existing BTI, you may want to contact the <u>customs administration of the Member State</u> which issued it. However, remember that, according to the provisions for data protection, there are limitations as to the information an administration can provide. You can search and consult existing BTIs on the <u>EBTI-database</u>.

CZECH REPUBLIC

The amendment of the Czech customs legislation cancels the obligation to pay guarantees for VAT

As of 1st January 2019, the new amendment of the Czech *Customs Code* should come into effect. This amendment abolishes the requirement to provide the guarantee for VAT that is currently required together with the guarantee for customs duties. As such, this amendment is very much appreciated by importers.

The legislative amendment was adopted as a reaction to the forthcoming end of the transition period for validity of authorizations for temporary storage and special procedures that were issued before 1st May 2016. This period will end on 1st May 2019.

The earlier customs legislation (i.e. the legislation valid until 1st May 2016) enabled the customs authorities to waive the requirement for provision of a guarantee for the customs duties and VAT for goods placed under special procedures, which is no longer available under the *Union Customs Code* valid as of 1st May 2016. Nevertheless, for authorizations issued before 1st May 2016, the customs authorities were still authorized not to require the guarantees. However, this will not be possible for the new authorizations for special procedures issued after 1st May 2019.

As such, the authorities decided to apply Art. 82 (2) of the *Union Customs Code* and implement new wording in the local customs legislation relating to the customs guarantees. According to the new wording, the customs authorities will not require that the guarantee that needs to be provided by importers for the customs duties also has to cover the VAT. The condition is that the person or entity is not considered as an unreliable tax payer according to the Czech *VAT Act*.

SWITZERLAND

Participation in "PANGEA XI"

The Swiss Government <u>reported</u> that in mid-October, authorities worldwide reviewed criminal online sales of medicines in a coordinated operation. Illegal erectile stimulants continue to dominate the market: 87% of the consignments confiscated by Swissmedic and the Swiss Federal Customs Administration (FCA) contained potency preparations.

This year Switzerland once again took part in the PANGEA international week of action coordinated by Interpol. A total of 116 countries were involved. The aim of this operation, now on its 11th outing, is to combat the illegal trade in medicinal products via the internet. Worldwide 10 million units illegal and counterfeit medicinal products were seized.

In Switzerland, the FCA, Swissmedic and Antidoping Switzerland checked over 1,000 shipments in the Zurich-Mülligen postal hub. 304 shipments containing illegal medicinal products or doping agents were confiscated, representing a sharp rise compared to previous years. 87% of the medicinal products seized during the operation were

erectile stimulants. Over the whole of 2017, potency preparations accounted for 59% of the confiscated shipments, double the percentage recorded just a few years ago.

Seizure of harmful potency preparations

The increase in confiscations is attributable to the closer cooperation between the FCA and Swissmedic. A simplified procedure for confiscating shipments was introduced several weeks ago and currently focuses on erectile stimulants. This efficient procedure implements the political will to get to grips with cross-border online trade.

The focus also resulted from the latest laboratory analyses carried out by Swissmedic on erectile stimulants obtained over the internet, which showed that the quality of these products is still poor: around half of approx. 100 preparations analysed were defective. The consumption of these products can pose a serious threat to health.

Specifically, the following shortcomings were found in 46 of the 96 preparations analysed:

- 13 preparations were deliberately massively overdosed or contained a medically alarming combination of two active substances
- 13 supposedly plant-based preparations or nutritional supplements contained undeclared active chemical substances.
- 2 preparations contained the wrong ingredient
- 17 preparations were incorrectly dosed
- 7 preparations contained not just a potency-enhancing active ingredient, but also other substances such as painkillers, antibiotics, immune-suppressants or heavy metals.

The illegal suppliers are also becoming increasingly creative and unscrupulous. Thus, for example, undeclared chemical substances were found in a chocolate bar or in a chocolate heart. Upon analysis, the chocolate heart was found to contain more than the maximum daily dose of the active substance sildenafil.

Illegal websites identified

As part of the operation, the authorities have also identified 27 illegal foreign websites masquerading as Swiss online pharmacies. The necessary steps have been initiated to have these internet sites deleted. Internationally operating criminal networks are often concealed behind supposedly serious suppliers on the internet.

The Pangea operation tracks online sales of counterfeit and illegal medicines in order to identify manufacturers and dealers so that they can be removed from the market – and, at the same time, make the buyers aware of the risks of such purchases.

The annual week of action coordinated by Interpol involves cooperation between customs, health and law enforcement agencies, as well as companies, from over 100 countries.

This year the authorities shut down 3671 websites with illegal online offerings. Some 859 individuals were arrested around the world, and 33 criminal organisations identified and reported. Worldwide, about 1 million shipments were checked and about 500'000 shipments with 10 million units illegal medicines confiscated.

Tightening of sanctions against Myanmar

On 17 October the Federal Council once again tightened sanctions against Myanmar due to its concerns over systematic human rights violations. Switzerland is thereby aligning itself with the sanctions adopted by the EU on 26 April and 25 June. The new provisions came into force at 6pm on 17 October 2018.

In addition to the existing embargo on arms and equipment that can be used for internal repression, the Federal Council on 17 October also banned the sale, supply, export and transit of dual-use goods to military end users and to military and border quard police end users in Myanmar. A corresponding ban also applies to equipment,

technology and software that can be used to monitor communications (internet, telephone).

In addition, an asset freeze and travel ban (entry and transit) have been imposed on certain natural persons. These measures are currently aimed at seven high-ranking members of Myanmar's military and security forces who are accused of serious human rights violations. The funds and economic resources of these individuals have been frozen and must be reported to SECO without delay.

The Federal Council condemns the ongoing widespread, systematic grave human rights violations committed by Myanmar's military and security forces, and is deeply concerned by the deteriorating human rights situation.

When sanctions against Myanmar were largely lifted on 9 May 2012, the Federal Council stressed that it would be prepared to tighten restrictive measures against Myanmar again in line with Switzerland's most important trade partners should the political situation in the country significantly deteriorate.

The Federal Council reaffirms its support for transition in Myanmar. Switzerland's ongoing cooperation efforts, which aim to promote peace, democracy and socioeconomic development in Myanmar, will continue.

UNITED KINGDOM

UK issues paper on sanctions policy if there is no Brexit deal

On 12 October, 2018, the Foreign and Commonwealth Office released <u>guidance</u> on the UK's sanctions policy if there is no Brexit deal. The guidance is part of a series of technical notices that sets out information to allow businesses and citizens to understand what they would need to do in a 'no deal' scenario, so they can make informed plans and preparations.

Prior to 29 March 2019, the UK is legally required to implement and enforce sanctions regimes agreed by the UN Security Council and, as a member of the EU, by the EU.

The details of sanctions regimes are set out in EU law, in European Council Decisions and Regulations. The UK implements sanctions through EU Regulations and associated UK domestic legislation, such as the *Export Control Order 2008* and the *Immigration Act 1971*.

After 29 March 2019, as international law requires, the UK will implement UN sanctions in UK domestic law after the UK leaves the EU.

If the UK leaves the EU without a deal, the UK will look to carry over all EU sanctions at the time of our departure and will implement sanctions regimes through new legislation, in the form of regulations, made under the <u>Sanctions and Anti-Money Laundering Act 2018</u> (the <u>Sanctions Act</u>). The Act will provide the legal basis for the UK to impose, update and lift sanctions after leaving the EU.

The Government proposes to put much of this legislation before Parliament before March 2019, to prepare for the possibility of the UK leaving the EU without a deal. Any sanctions regimes that the Government did not address, through regulations under the Sanctions Act by March 2019, would continue as retained EU law under the *EU (Withdrawal) Act 2018*. This means there will be no gaps in implementing existing sanctions regimes.

We expect that the UK's sanctions regulations will include:

- the purposes of the sanctions regime (what the UK hopes will be achieved through imposing sanctions)
- the criteria to be met before sanctions can be imposed on a person or group
- details of sanctions, such as trade and financial sanctions
- details of exemptions that may apply, such as exemptions which allow people to trade with a certain country that would otherwise be prohibited by the regulations

- how the UK will enforce the sanctions measures
- other areas, such as circumstances in which information about sanctions may be shared

The names of sanctioned persons or organisations would be <u>published as normal</u>.

After the UK leaves the EU, in addition to implementing UN sanctions, and looking to carry over existing EU sanctions, the UK will also have the powers to adopt other sanctions under the Sanctions Act. The UK will work with the EU and other international partners on sanctions where this is in our mutual interest.

If there is no Brexit deal, persons affected by sanctions are advised refer to the <u>Sanctions Act</u> and the UK regulations made under it. If the UK has not yet made regulations for the sanctions regime in question, the EU Council Regulations retained under the <u>EU Withdrawal Act 2018</u>, (which may be modified under that Act) are to be followed.

One should not assume that all aspects of existing EU sanctions will be replicated exactly. <u>New legislation</u> and future guidance should be checked and complied with.

OFSI release annual review

The Office of Financial Sanctions Implementation (OFSI), part of HM Treasury, has issued an <u>annual review</u> covering the period April 2017-March 2018. OFSI was set up in March 2016 to be a centre of excellence for financial sanctions. Its objectives are to raise awareness of financial sanctions, to assess and address suspected breaches and provide a professional service to the public and industry. In 2017-18, the UK implemented 29 financial sanctions regimes. International sanctions were imposed for reasons including preventing terrorist financing, preventing nuclear proliferation, human rights abuses and the violation of national sovereignty, as well as the misappropriation of assets. In addition, OFSI is responsible for implementing domestic asset freezes under three UK Acts of Parliament:

- Terrorist Asset Freezing etc. Act 2010
- Anti-Terrorism, Crime and Security Act 2001
- Counter Terrorism Act 2008

Turkey introduces export proceeds obligations

Recent Development

The Ministry of Treasury and Finance published the <u>Communiqué No. 2018-32/48 on the Decree No. 32 on the Protection of the Value of Turkish Currency</u> ("Communiqué"), introducing an obligation for Turkish resident exporters to bring export proceeds into Turkey.

The Communiqué, which entered into force through its publication on the Official Gazette on September 4, 2018, will be valid for six months.

This article lays out the most significant issues introduced by the Communiqué.

What Does the Communiqué Say?

- According to the Communiqué, proceeds arising from Turkish residents' export transactions must be directly brought or transferred to the intermediary bank immediately upon the importer's payment.
- The proceeds must be brought into Turkey within 180 days as of the actual export transaction.
- At least 80% of the proceeds must be converted into Turkish lira.
- The export proceeds can be paid through one of the following: (a) letter of credit;
 (b) cash against documents; (c) cash against goods; (d) acceptance credit; (e) documents against acceptance; (f) goods against acceptance; or (g) advance payment.
- The Communiqué's primary law is to return export proceeds to Turkey, whether
 in the Turkish or foreign currency declared during exportation; however, exporters can also bring the export proceeds in foreign currency for export transactions
 made based on Turkish currency.
- For export proceeds paid in advance in foreign currency, the export transaction must be realized within 24 months.
- The Communiqué introduces different time limits for export proceeds falling within the scope of "special export" transactions (exports to contracting firms; exports on consignment; temporary exports; and exports credits or leases within the scope of the current Export Regime and Financial Leasing legislation).
- Exporters are responsible for bringing the export proceeds into Turkey, selling them to banks and closing the export accounts by the stipulated deadline.
- Intermediary banks are responsible for monitoring the processes of bringing the export proceeds into Turkey and the sale to banks.
- Intermediary banks will close the relevant export accounts for export proceeds relating to commercial goods brought into Turkey by the stipulated deadline.
- Intermediary banks will notify the tax office of any export accounts that are not
 closed by the stipulated deadline in written form and within five business days.
 Within ten days of this notification, the tax office will send the relevant persons a
 warning letter requesting the closure of the accounts within 90 days. The ac-

counts must be closed within this deadline or the account owners must provide and prove the existence of force majeure events or other justifiable reasons. Otherwise, the account owners would be subject to the legal sanctions foreseen in the Law on the Protection of the Value of Turkish Currency.

 The obligations for export transactions made while the Communiqué is in force will remain in force even after the deadline for bringing export proceeds into Turkey ends with the abolishment of this Communiqué.

Conclusion

Turkey imposed similar export proceeds obligations in the past, which were abolished in 2008 through an amendment to the Decree No. 32 allowing exporters to freely dispose of their export proceeds, i.e. without bringing them into Turkey. It appears that Turkey resuscitated these obligations due to the recent currency deprecation.

Within this context, Turkish residents who export goods abroad should be aware of the Communiqué's temporary obligations for bringing export proceeds into Turkey.

Exporters who converted their export proceeds into Turkish lira in line with the Communiqué will be able to freely dispose of these export proceeds afterwards.

Turkey publishes draft regulation on authorization of traditional herbal medical products

Recent Developments

The Turkish Medicines and Medical Devices Agency ("TİTCK") recently published on its website the draft Regulation on Authorization of Traditional Herbal Medicinal Products ("Regulation"). Within the scope of harmonization with EU legislation, the Regulation is based on the EU Directives No. 2001/83/EC and 2004/24/EC.

What's New?

The Regulation sets out the procedures and principles for the authorization, packaging and distribution of medical herbal products. The Regulation aims to increase the efficiency and reliability of these products and ensure that they meet the required quality standards.

Products that do not comply with the Regulation will not be authorized and therefore will not be placed into the market. The Regulation lists the required documents and sets out the procedure for the authorization process. The Regulation clarifies the evaluation process and the objection mechanisms concerning the evaluation process in detail.

The Regulation also introduces certain requirements for the packaging of herbal medicinal products. Medical herbal products must contain usage instructions prepared in line with the requirements under the Regulation.

Turkey publishes draft regulation on foods for medical purposes Recent Development

The Turkish Medicines and Medical Devices Agency ("TİTCK") recently published on its website the draft Regulation on Foods for Medical Purposes ("Regulation"). Within the scope of harmonization with EU legislation, the Regulation is based on the EU Directive 609/2013/EC.

What's New?

The Regulation sets out the labelling rules, procedures and principles for the authorization and packaging of products intended for medical use. The Regulation aims to ensure that the products are appropriate for human health and food safety.

The formulation of the products for medical purposes must be based on internationally recognized principles of medicine and nutrition. Companies must also ensure that the products meet the specific nutritional requirements when used in accordance with the specified instructions, and that the products are scientifically proved to be useful and effective.

In addition, companies must obtain an authorization certificate from the TİTCK before they introduce their products to the market. Companies should submit the relevant information and documents for the products listed under the Regulation to the TİTCK.

Classification decisions adopted by the Commission and preliminary decisions adopted by the States-Members

The Commission has posted a table which provides a <u>collection of classification</u> <u>decisions</u> under the common tariff adopted by the Commission. A separate website exists for <u>preliminary decisions</u> on the <u>classification of goods adopted by the customs authorities of states - members</u> of the Eurasian Economic Union. It was last updated 24 October 2018. The table lists the tariff codes, a description, rationale (GRIs) for the decision.

BELARUS

Preliminary decisions on tariff classification

The State Customs Committee maintains a <u>searchable database of preliminary decisions on the tariff classification of goods</u> (База данных товаров, в отношении которых принято предварительное решение о классификации). The database has been updated through September 2018. It may be searched by tariff code or description (in Russian).

RUSSIAN FEDERATION

Russia introduces new countersanctions against Ukraine

On 22 October 2018, Russian President Vladimir Putin <u>signed a decree</u> calling for countersanctions against Ukraine and instructing the Russian Government to draw up a list of companies and individuals that will be subject to economic restrictions under the new measures and also a list of the respective restrictions.

The restrictive measures the Russian Government may impose, subject to a decision of the Russian President, could include:

- Suspension or termination of cooperation of Russia and Russian legal entities with Ukraine and with entities affiliated with or controlled by Ukraine;
- A ban or restriction on the import of products and/or raw materials originating from Ukraine or manufactured by entities affiliated with or subject to the jurisdiction of Ukraine (the list of products and/or raw materials will be determined by the Russian Government);
- 3. A ban or restriction on the export of products and/or raw materials by entities under the jurisdiction or control of Ukraine (the list of products and/or raw materials will be determined by the Russian Government);
- 4. A ban or restriction on the performance of work or provision services for Russian state and municipal needs, and for the needs of certain kinds of legal entities, by entities under the jurisdiction of Ukraine (the list of works/services will be determined by the Russian Government);
- 5. A ban or restriction on the participation of citizens and legal entities of certain Ukrainian in the privatization of state and municipal property, in the performance of work or provision of services related to the sale of federal property, and/or in the performance of the functions of a seller of federal property; and
- 6. Other measures as determined by the President of Russia.

The decree further states that it may be repealed in the event that Ukraine cancels the restrictive measures it has implemented against Russian citizens and legal entities.

The decree itself does not impose any countersanctions against Ukraine. It is expected that the respective restrictive measures would be imposed by the Rus-

sian Government in the nearest future. Baker McKenzie will monitor further developments.

SOUTH AFRICA

South Africa welcomes product exclusions from US sec. 232 tariffs

On 24 October 2018, the Department of Trade and Industry (DTI) issued a <u>press release</u> stating that the US Department of Commerce has granted product exemptions for imports from South Africa of 161 aluminium and 36 steel products from the Section 232 duties that the United States imposed against foreign imports. The product exemptions are applicable to companies whose buyers in the United States made requests to the Commerce Department for the products to be excluded from the Section 232 duties.

South Africa urged its exporters of steel and aluminium to encourage their buyers and distributors to consider applying for product exemption. The products that have been exempted for aluminium include aluminium foil and aluminium plates, sheets and strip. In relation to steel, the products include the hot rolled bars, hot rolled sheets, cold rolled sheets, plates cut and plates in coils.

The Government of South Africa has also made submissions to the US Government requesting a country exemption from Section 232 duties, and remains in contact with both USTR and the US Commerce Department on that matter. Over 800 US companies are represented in South Africa and the trade between the Parties is relatively balanced with total trade reaching R161.4 billion in 2017.

Madagascar launches two safeguard investigations: on pasta and on blankets

On 8 October 2018, the WTO <u>announced</u> that Madagascar notified the WTO's Committee on Safeguards that it initiated on 20 September 2018 two safeguard investigations: one on pasta and another on blankets. In both notifications

Madagascar indicated, among other things, that:

"Any entity wishing to be considered as an interested party must register with the ANMCC [i.e. investigating authority] within 30 days of the date of initiation of the investigation. Any comments, information or requests that interested parties wish to forward to the investigating authority should be submitted within 30 days of the date of initiation of the investigation.
